PARTIAL RELEASE OF MORTGAGE

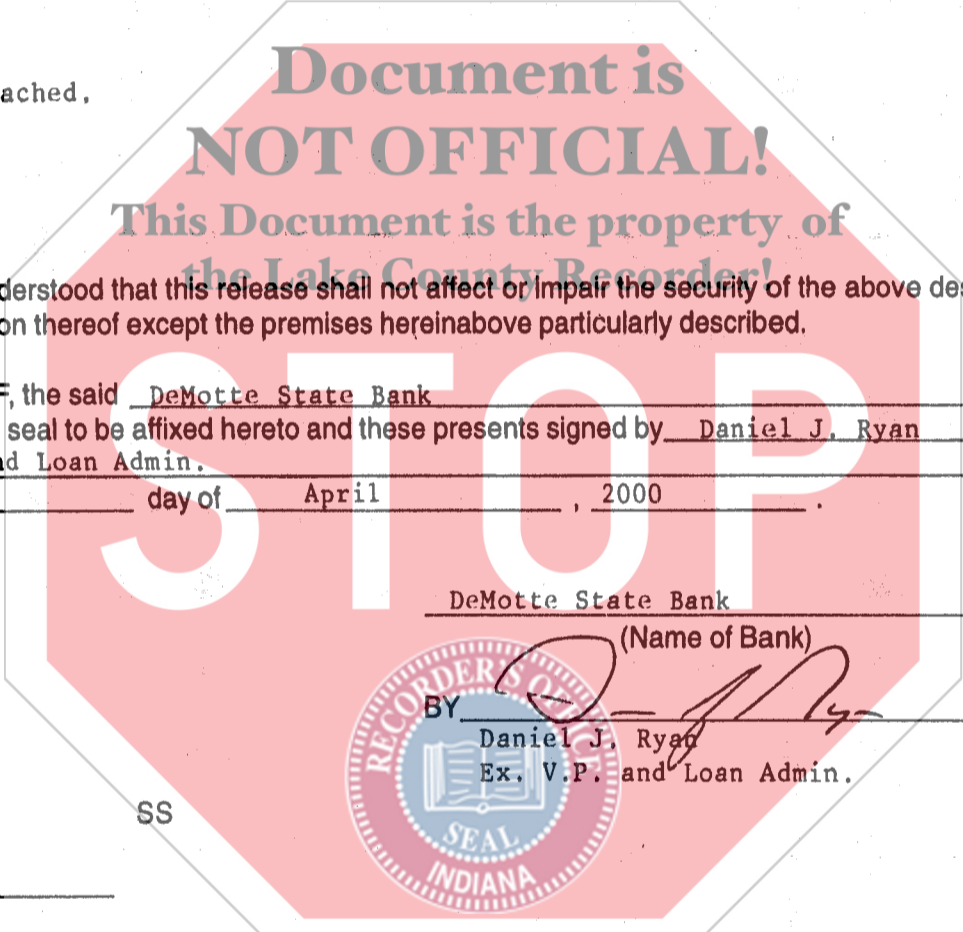
KNOW ALL MEN BY THESE PRESENTS, that DeMotte State Bank

Exhibit "A"

Part of the Southwest 1/4 of Section 32, Township 34 North, Range 7 West of the 2nd Principal Meridian, in Lake County, Indiana, being more particularly described as follows:

Commencing at the Southwest corner of said Section 32; thence North 00 degrees 00 minutes 00 seconds East, along the West line of said Section, a distance of 2666.87 feet to the Northwest corner of the Southwest 1/4 of said Section; thence North 89 degrees 59 minutes 06 seconds East, along the North line of the Southwest 1/4, a distance of 2,052.71 feet to the point of beginning; thence continuing North 89 degrees 59 minutes 06 seconds East, along last described line, a distance of 589.14 feet to the Northeast corner of the Southwest 1/4 of said Section; thence South 00 degrees 08 minutes 40 seconds West, along the East line of said Southwest 1/4, a distance of 324.14 feet; thence North 89 degrees 51 minutes 20 seconds West, a distance of 588.24 feet; thence North 00 degrees 00 minutes 54 seconds West, a distance of 322.50 feet to the point of beginning.
