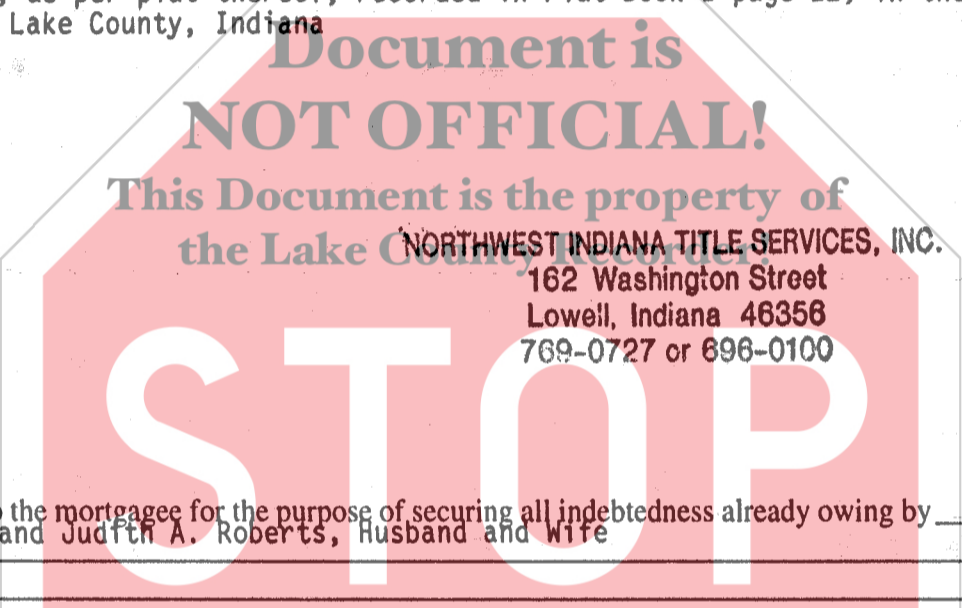

INDEMNIFYING MORTGAGE
