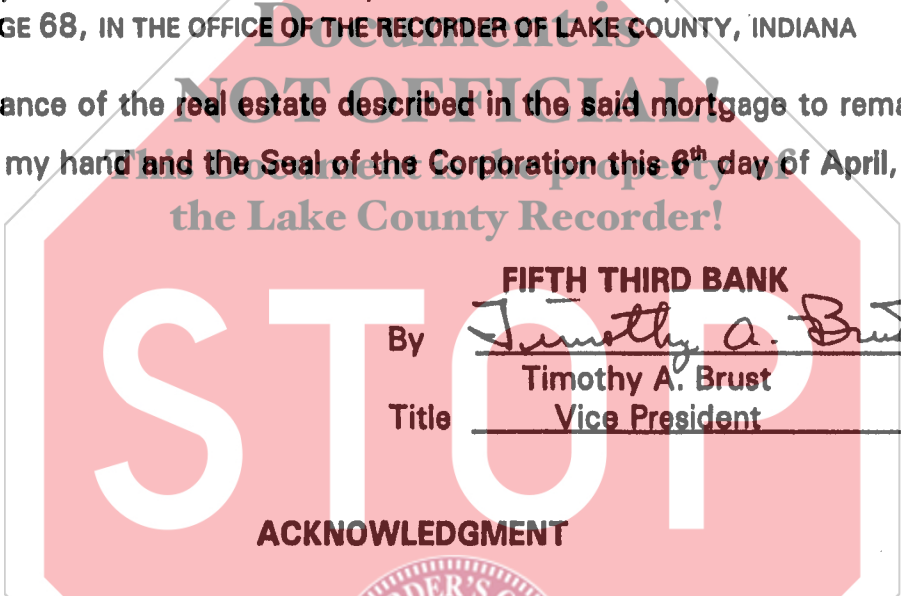
PARTIAL SATISFACTION OF MORTGAGE

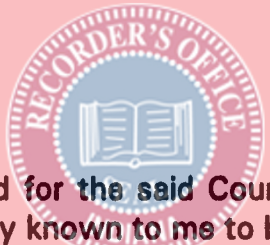
