This obligation may be cancelled by said Surety by giving thirty (30) days notice in writing of its intention so to do to said Oblige; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Oblige.

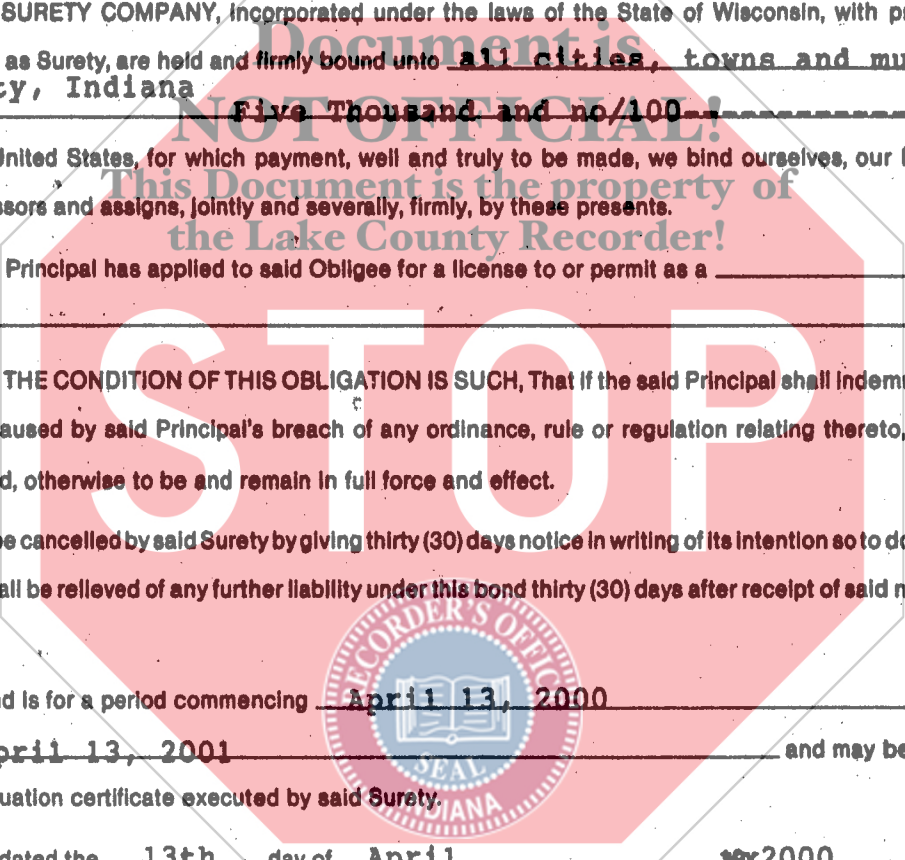
The term of this bond is for a period commencing April 13, 2000 and terminating April 13, 2001 and may be continued from year to year by continuation certificate executed by said Surety.
