This power of attorney is granted under and by authority of Subsection 5.1 (b) of Article V of the by-laws of CGU insurance Company which became effective February 20, 1992 and which provisions are in full force and effect, reading as follows: "5.1(b) The Board of Directors or President, Vice President, or other officer designated by them or either of them shall have power to appoint Attorneys-in-Fact and to authorize them to execute on behalf of the Company bonds and undertakings, recognizances, contracts of Indemnity and other writings obligatory in the nature thereof, and to attach the seal of the Company thereto; and shall also have the power to remove any such Attorney-in-Fact at any time and revoke the power and authority given to him?
