# TAX DEED

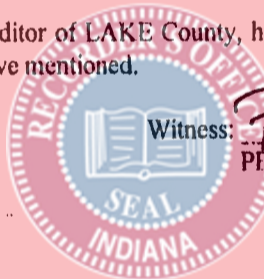
