# TAX DEED

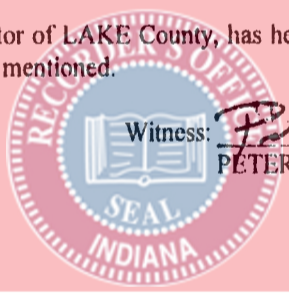
