decedent's death, listed under the laws of intestacy are the decedent's children, namely:

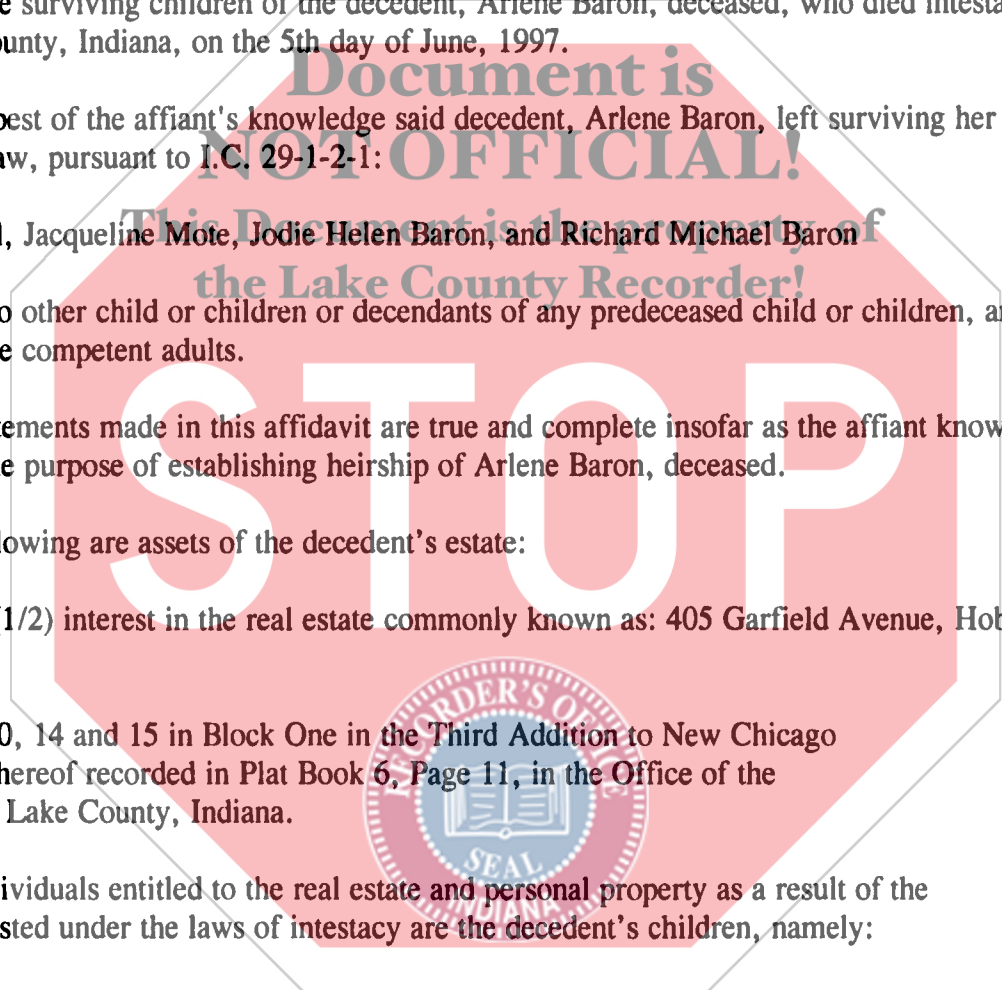
Paulette Hill, Jacqueline Mote, Jodie Helen Baron and Richard Michael Baron

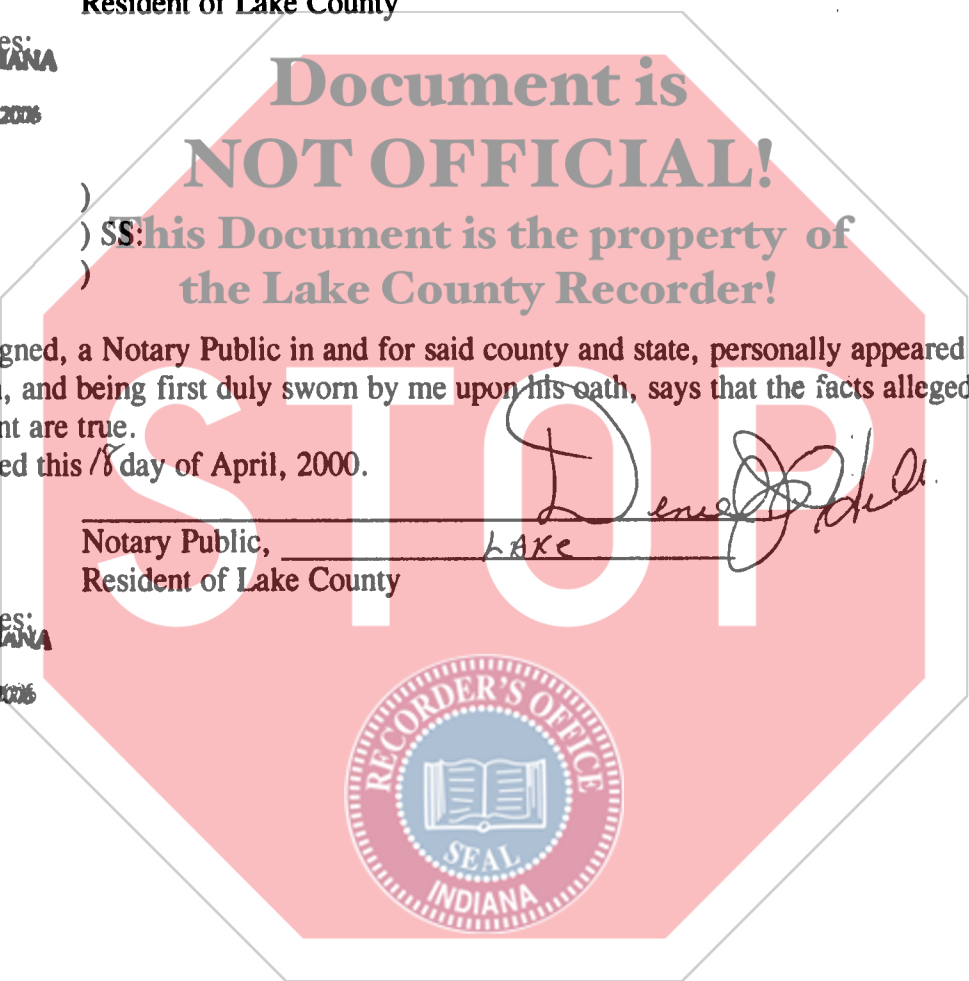
