Part of the East Half of the West two-thirds of the Northwest Quarter of the Northeast Quarter of Section 26, Township 36 North, Range 9 West of the 2nd Principal Meridian, described as follows: Commencing at a point in the center line of Ridge Road which is 74.14 feet (measured along said center line of Ridge Road) Easterly of the West line of East Half of the West two-thirds of the Northwest Quarter of the Northeast Quarter of said Section and running thence Easterly along the said center line of Ridge Road 74.14 feet, thence South 250 feet, thence Westerly parallel with said center line of Ridge Road 74.14 feet, thence North 250 feet to the place of beginning, Also Part of the East half of the West two-thirds of the Northwest Quarter of the Northeast Quarter of Section 26, Township 36 North, Range 9 West of the 2nd Principal Meridian, described as follows: Commencing at a point 20 feet North of South line of Said Northwest Quarter of the Northeast Quarter of Section 26 and 78.573 feet East of West line of East Half of the West two-thirds of said Northwest Quarter of the Northeast Quarter of Section 26, thence North 501.35 feet, thence Easterly parallel to the center line of Ridge Road 69.05 feet, thence South 492.85 feet, thence West and parallel to said South line of said Northwest Quarter of the Northeast Quarter of Section 26 a distance of 68.51 feet to the place of beginning all in the Town of Griffith, Lake County, Indiana.


