MORTGAGE MODIFICATION AGREEMENT

Mortgagor, for valuable consideration given by Mortgagee, the receipt and sufficiency of which is hereby acknowledged, does hereby agree that the certain Mortgage dated the 16th day of July, 1999, recorded the 3rd day of August 1999, in the Office of the Recorder of Lake County, Indiana, as Document No.99064304(herein the "Mortgage"), is hereby amended as follows:

1. **Note Modification, Renewal, Replacement, Rewrite or Extension.** The promissory note referenced in paragraph 1 of the Mortgage in the original principal amount of \$30,000.00 and dated the 16th day of July, 1999, (herein the "Note") has been modified as follows:
 - 1.01. **Rewrite.** The Note has been rewritten by Mortgagor's promissory note dated April 16, 2000, in the original principal amount of \$32,916.82 (the "Replacement Note"). Mortgagor agrees that the Mortgage shall secure the payment of the Rewrite Note, and any renewal, extension, modification, refinancing or replacement thereof, and all interest, attorney fees, and costs of collection with respect thereto. The Rewrite Note is given in substitution for and not in discharge of the indebtedness evidenced by the Note.
2. **Miscellaneous.** The Mortgagor further agrees as follows:
 - A. All terms and conditions of the Mortgage not expressly deleted or amended by this Mortgage Amendment Agreement shall remain in full force and effect to the extent not expressly inconsistent herewith.
 - B. This Mortgage Amendment Agreement shall in all respects be governed by and construed in accordance with the substantive laws of the State of Indiana.
 - C. This Mortgage Amendment Agreement shall be binding upon the respective heirs, successors, administrators and assigns of the Mortgagor.
