Subject to any and all easements, covenants, agreements, restrictions and other matters of record.

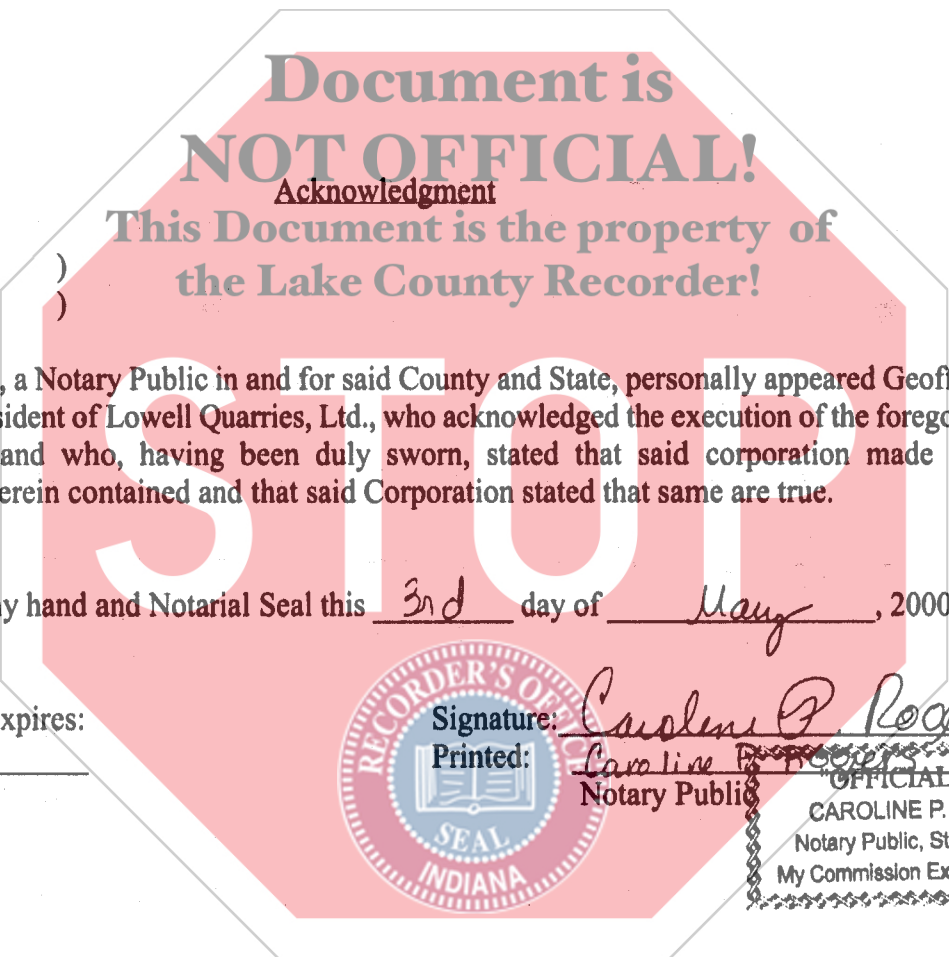
