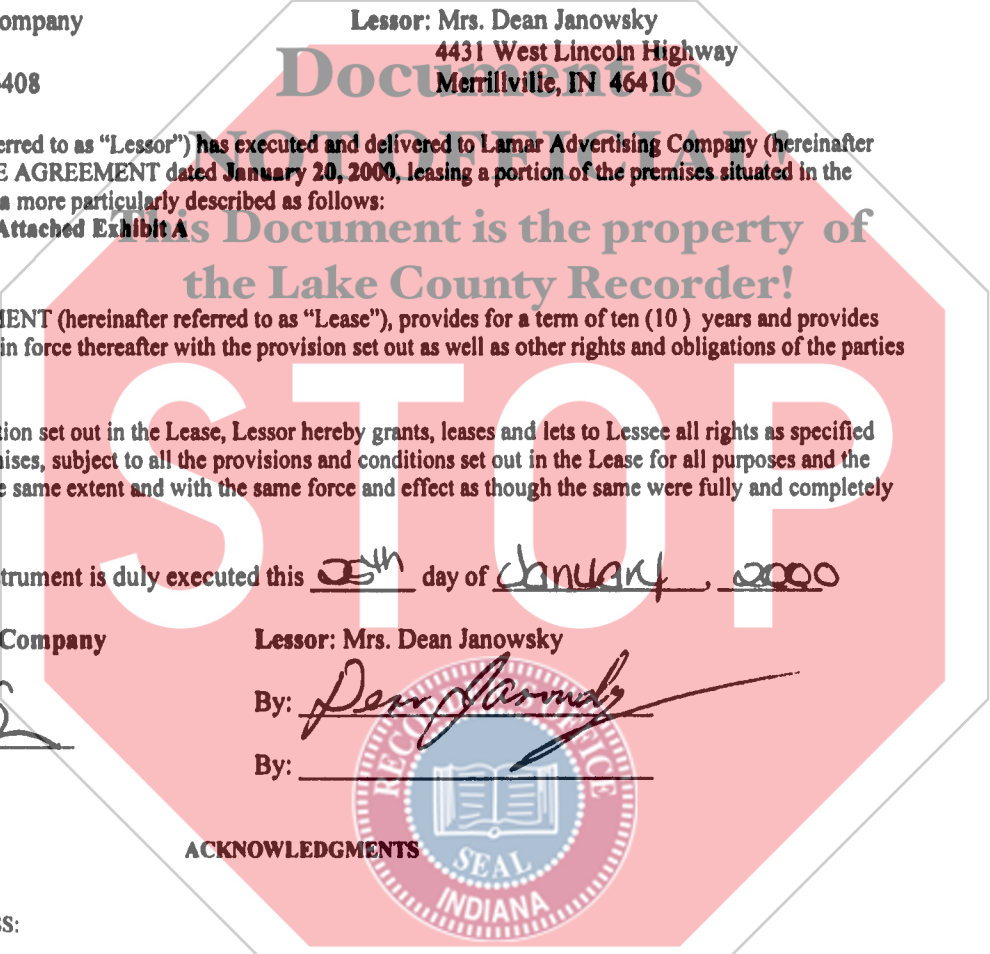

Part of the northwest Quarter of Section 19, Township 35 North, Range 8 West being more particularly described as follows:
