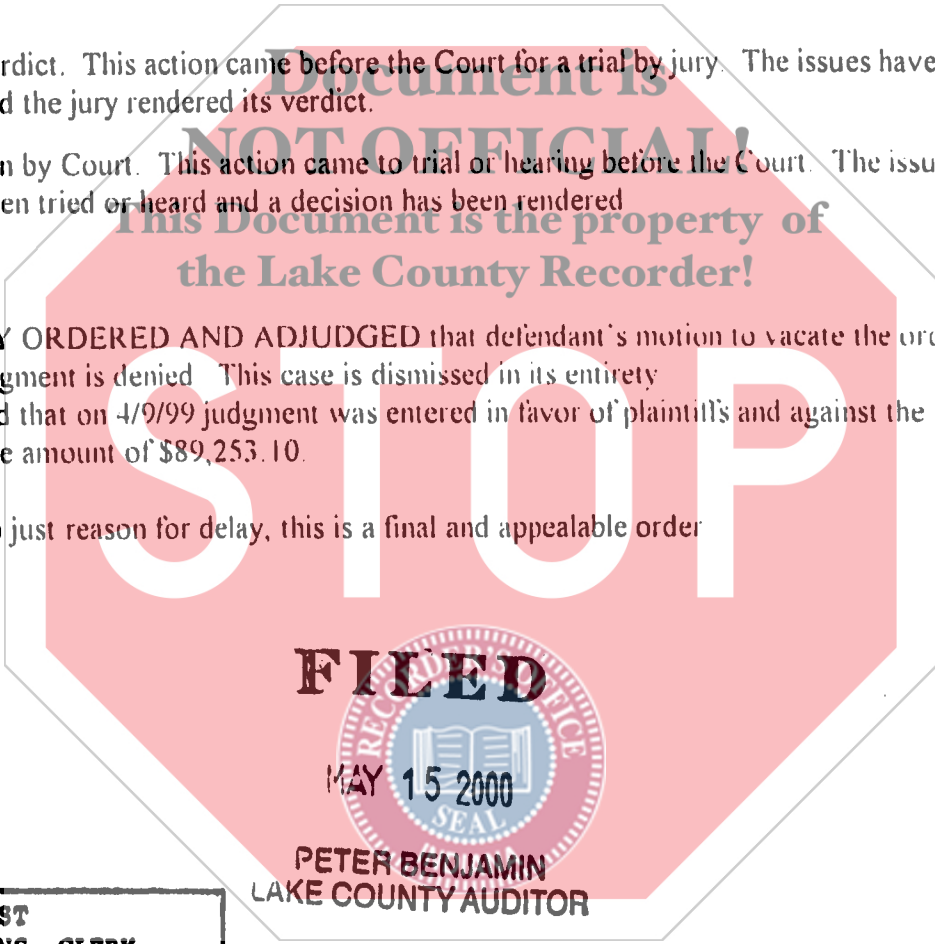

The East 1/2 of the Northwest 1/4 of Section 14, Township 34 North, Range 9 West of the 2nd P.M. in Lake County, Indiana, except the following described parcel:

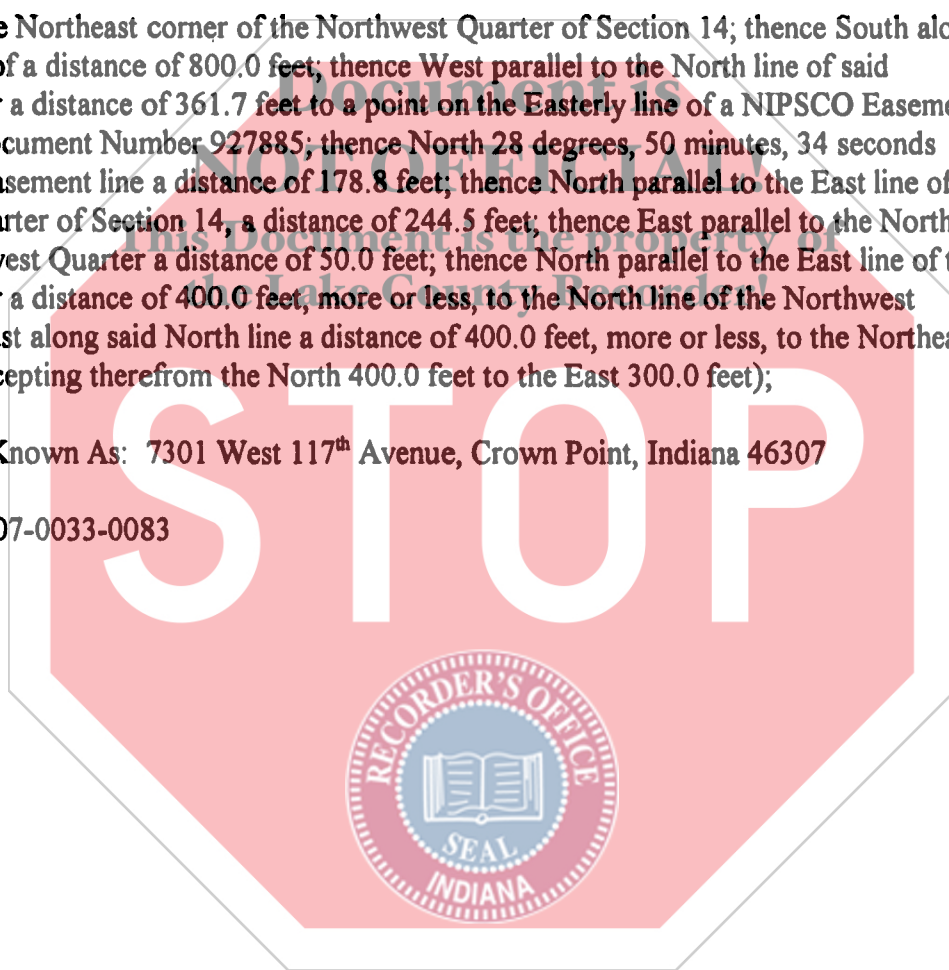
