In consideration thereof, the Principal is granted a license and/or permit by the Obligee to engage in the business of carpentry

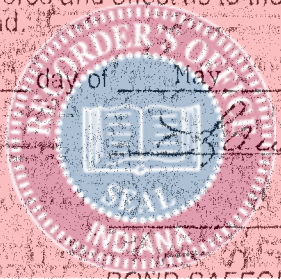
for the period beginning on the 24th day of May, 2000

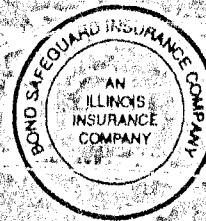

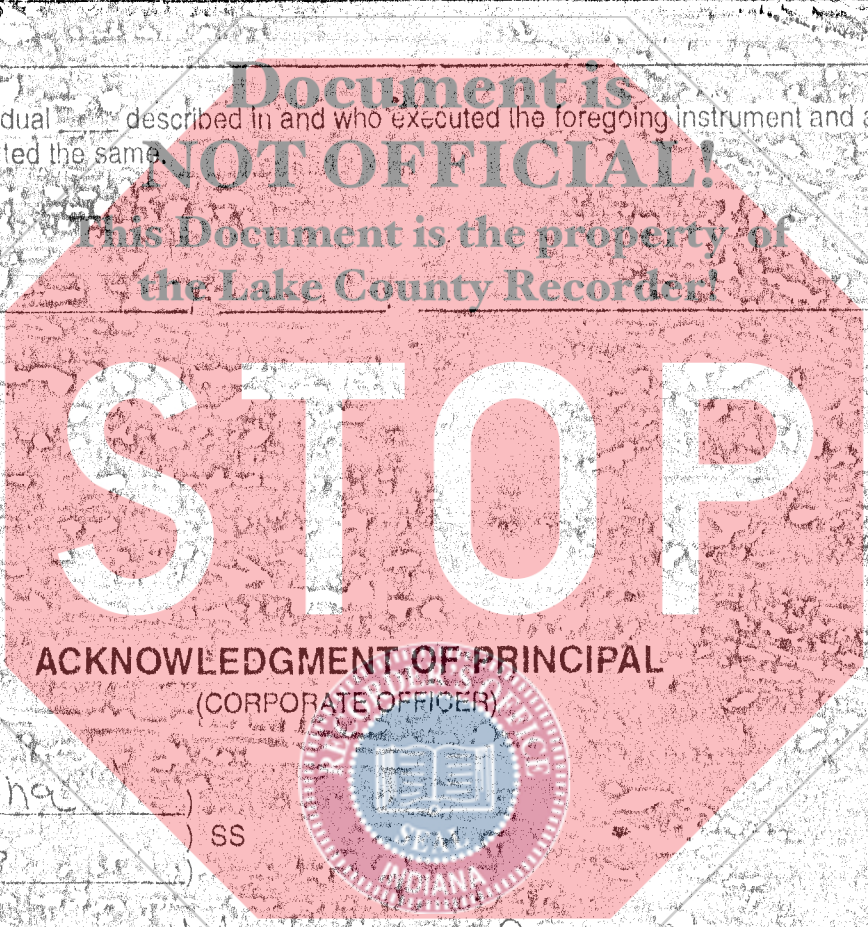
