**SECOND AMENDED SWORN STATEMENT OF INTENTION TO HOLD LIEN

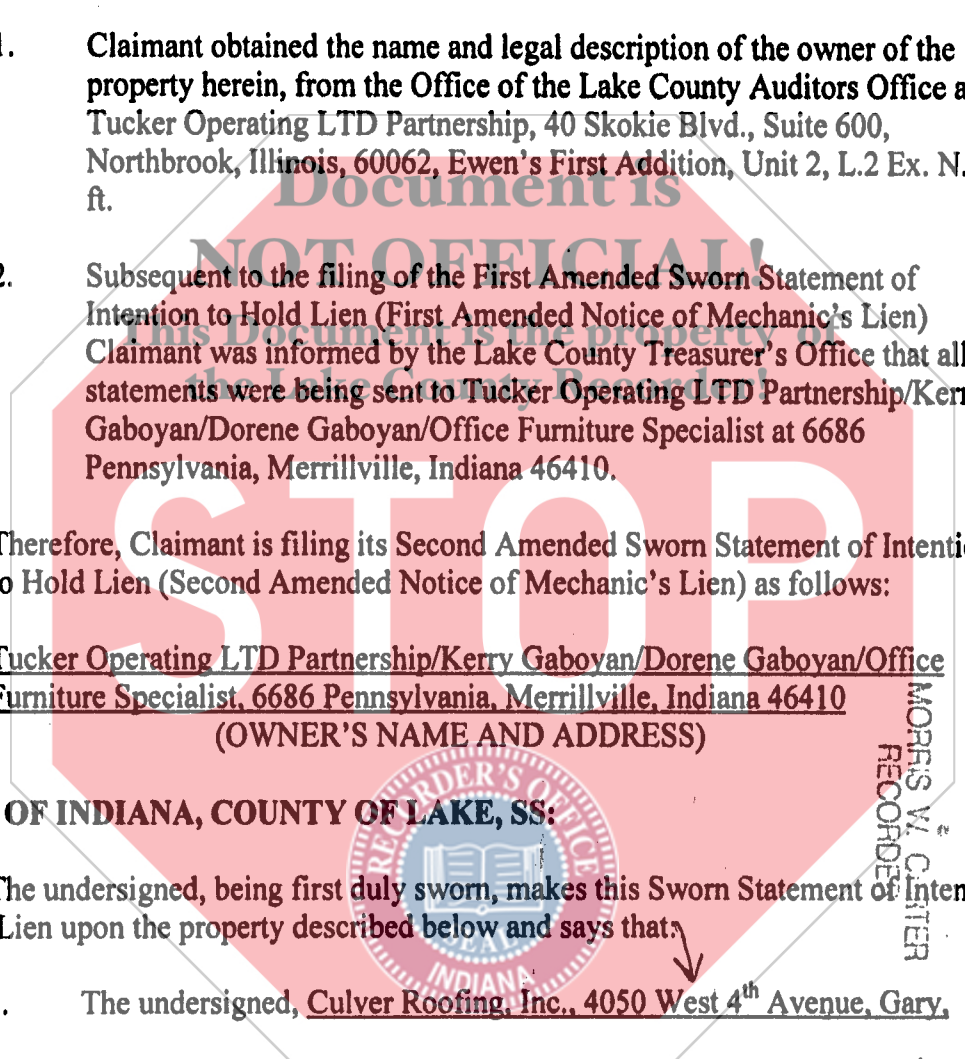

by the undersigned in the erection, construction, altering, repairing and removing of said buildings, structures, and improvements for such work and labor and for such materials and machinery.

More Specifically:

1. **Vacuumed all loose gravel from the existing roof surface. Saved 1 ½" gravel on the existing ballasted rubber roof for redistribution.**
2. **Removed the metal edge flashing around the perimeter of the existing ballasted rubber roof.**
3. **Replaced/refastened the existing perimeter wood blocking as needed at the existing ballasted rubber roof. Installed new wood blocking at the perimeter of the existing tar and gravel roof.**
4. **Loose laid one (1) layer of ½" high-density wood fibered insulation over the entire roof surface.**
5. **Installed a Firestone .045 mil EPDM ballasted roof system. Roof system included all flashings at drains, scuppers, stacks, gravel stop, and curbs. Roof system installed according to the manufacture's published specifications.**
6. **Installed new metal edge flashing around the entire perimeter. Re-installed missing gutter at the northeast corner of the building.**
7. **Re-ballasted roof with saved/new 1 ½" river rock at the rate of 10 pounds per square foot at the perimeter and 8 pounds per square foot on the remainder.**

More Specifically:

1. **Vacuumed all loose gravel from the existing roof surface. Saved 1 ½" gravel on the existing ballasted rubber roof for redistribution.**

4. **Loose laid one (1) layer of ½" high-density wood fibered insulation over the entire roof surface.**
5. **Installed a Firestone .045 mil EPDM ballasted roof system. Roof system included all flashings at drains, scuppers, stacks, gravel stop, and curbs. Roof system installed according to the manufacture's published specifications.**
6. **Installed new metal edge flashing around the entire perimeter. Re-installed missing gutter at the northeast corner of the building.**
7. **Re-ballasted roof with saved/new 1 ½" river rock at the rate of 10 pounds per square foot at the perimeter and 8 pounds per square foot on the remainder.**

2. The amount claimed under this statement is Ninety Thousand Nine Hundred thirty-one Dollars and 68/100 (\$90,931.68).

3. The work and labor were done and the materials and machinery were furnished by the undersigned within the last ninety (90) days.

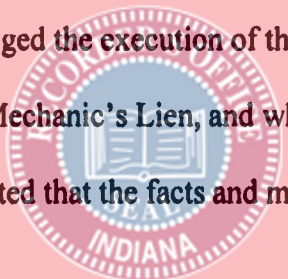
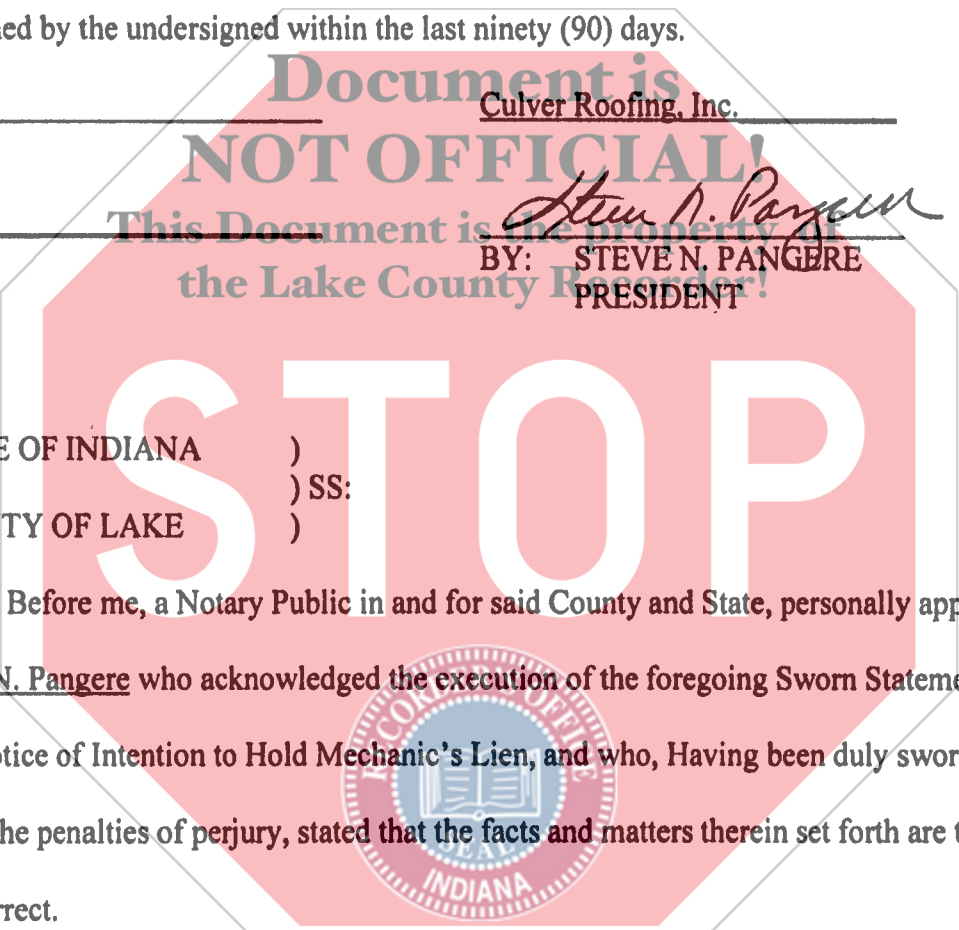
