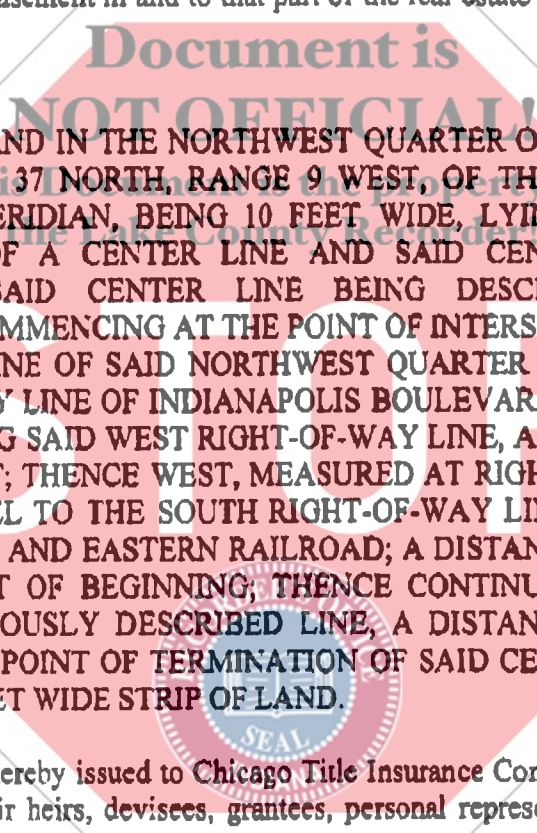

KNOWN ALL MEN BY THESE PRESENTS, that for value received, receipt of which is hereby acknowledged, Northern Indiana Public Service Company a/k/a NIPSCO, ("NIPSCO") grantee of a certain easement in the real estate located in Section 32, Township 37 North, Range 9 West, County of Lake, State of Indiana, under the terms of a written grant executed by Lake County Trust Company, as Trustee under Trust No. 2017, on December 3, 1974, and recorded in the Office of the Recorder of Lake County, Indiana on January 20, 1975, as Document No. 285120, hereby agrees to and hereby does release its right in said easement in and to that part of the real estate as herein described; to wit:

A STRIP OF LAND IN THE NORTHWEST QUARTER OF SECTION 32, TOWNSHIP 37 NORTH, RANGE 9 WEST, OF THE SECOND PRINCIPAL MERIDIAN, BEING 10 FEET WIDE, LYING 5 FEET EACH SIDE OF A CENTER LINE AND SAID CENTER LINE PRODUCES; SAID CENTER LINE BEING DESCRIBED AS FOLLOWS: COMMENCING AT THE POINT OF INTERSECTION OF THE SOUTH LINE OF SAID NORTHWEST QUARTER AND LAST RIGHT-OF-WAY LINE OF INDIANAPOLIS BOULEVARD; THENCE NORTH, ALONG SAID WEST RIGHT-OF-WAY LINE, A DISTANCE OF 354.74 FEET; THENCE WEST, MEASURED AT RIGHT ANGLES AND PARALLEL TO THE SOUTH RIGHT-OF-WAY LINE OF THE ELGIN, JOLIET AND EASTERN RAILROAD; A DISTANCE OF 855, TO THE POINT OF BEGINNING; THENCE CONTINUING WEST ALONG PREVIOUSLY DESCRIBED LINE, A DISTANCE OF 255 FEET, TO THE POINT OF TERMINATION OF SAID CENTER LINE OF SAID 10 FEET WIDE STRIP OF LAND.
