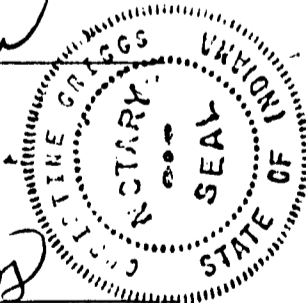

I declare that I am now a widow and that I have not remarried.

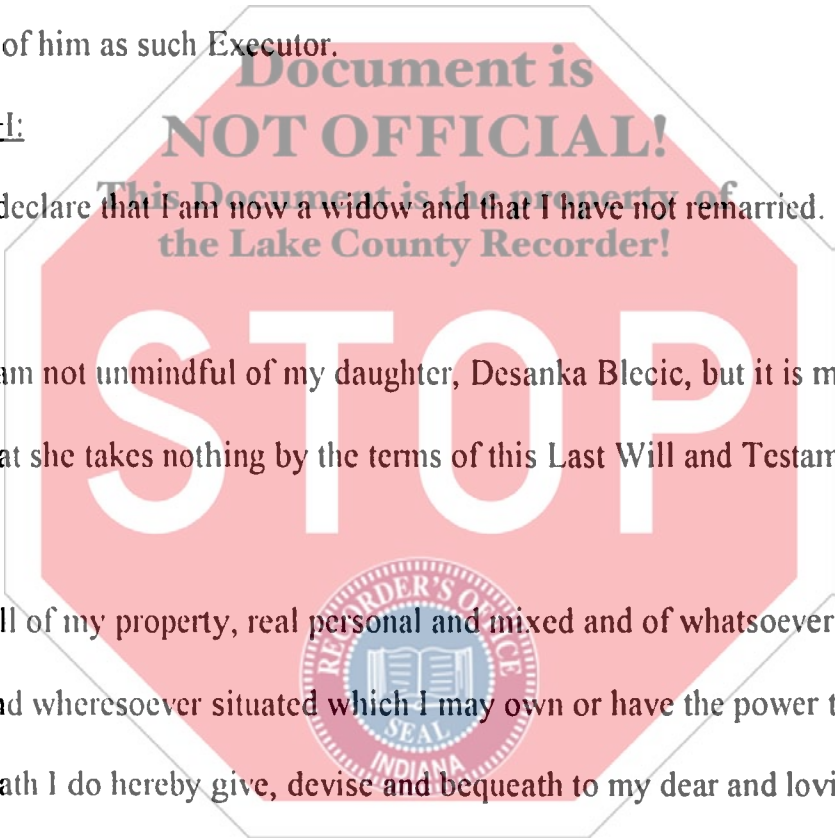
FIFTH:
