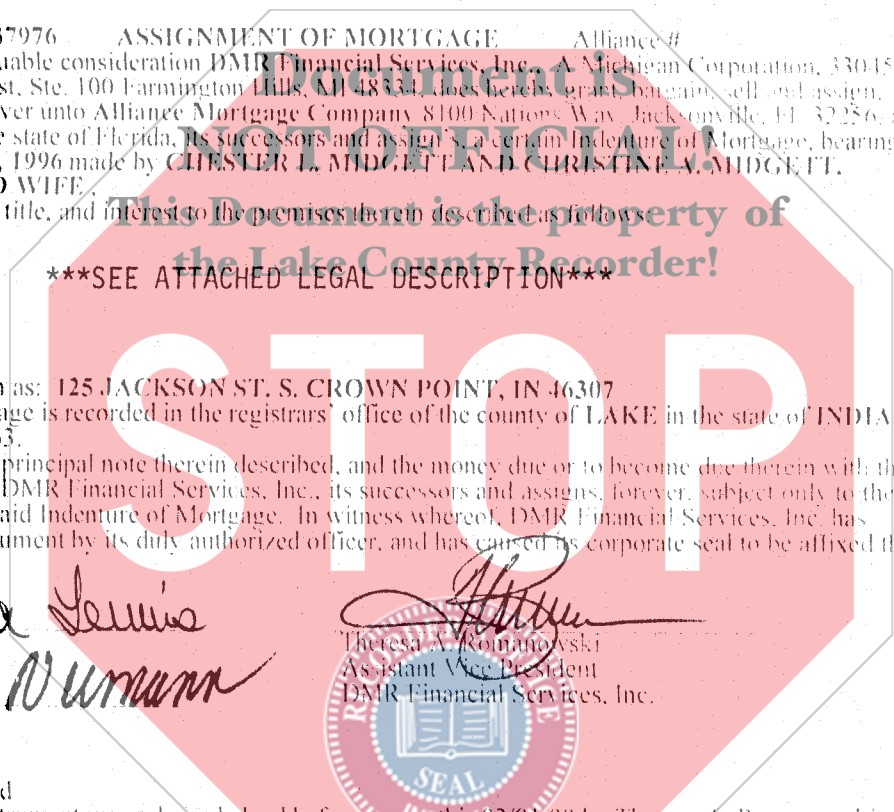

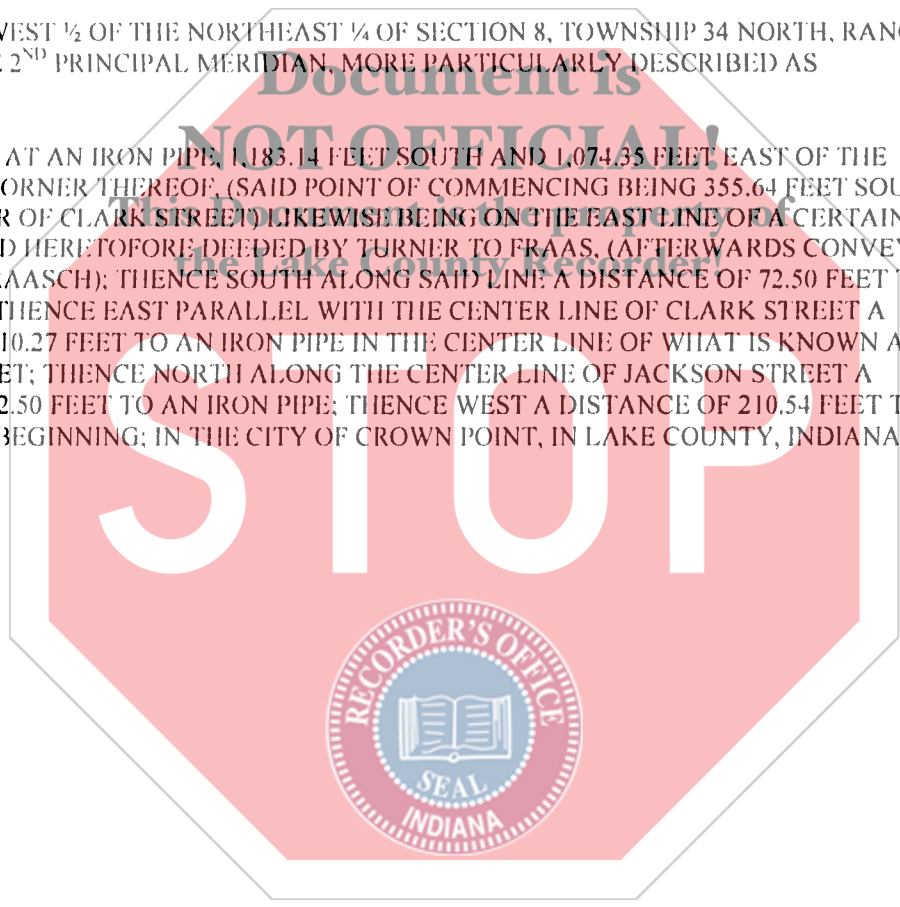
LEGAL DESCRIPTION
