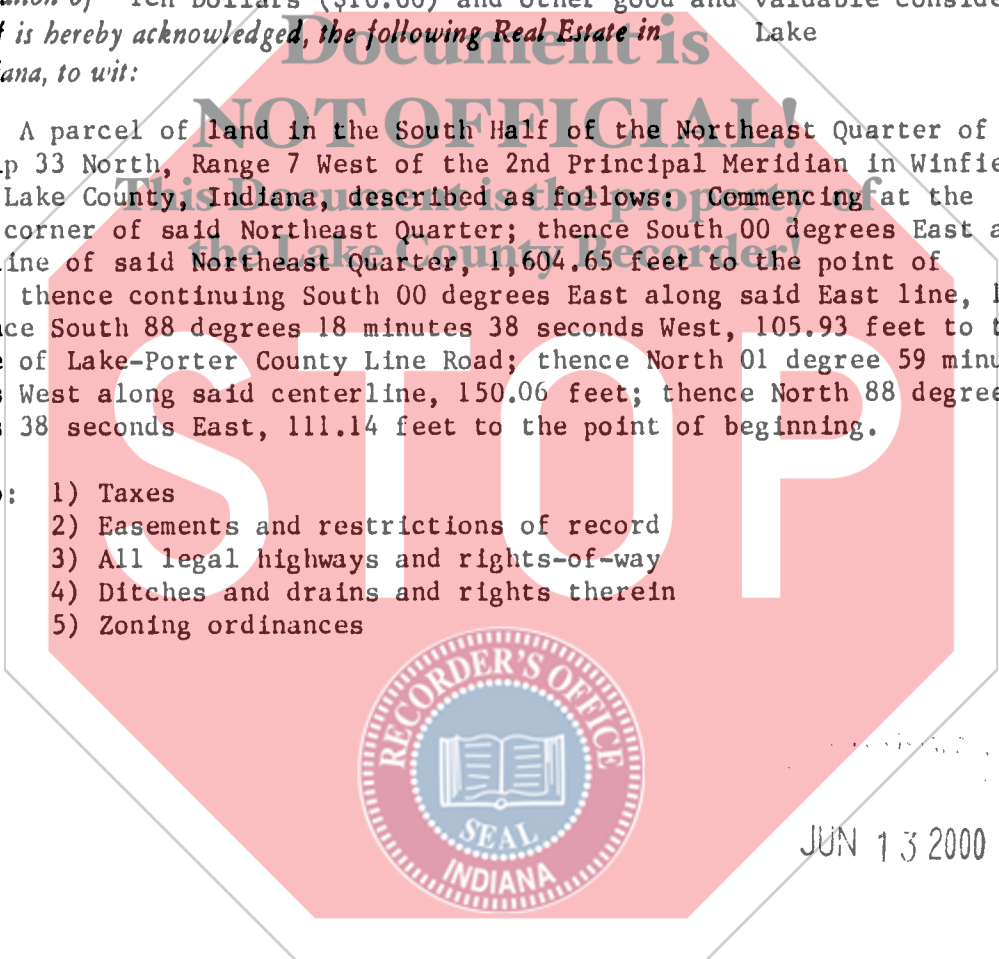
Convey and warrant to Frank R. Gonzalez and Amber Gonzalez, husband and wife
