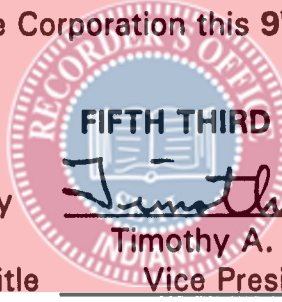
PARTIAL SATISFACTION OF MORTGAGE
