STATEMENT OF LIEN

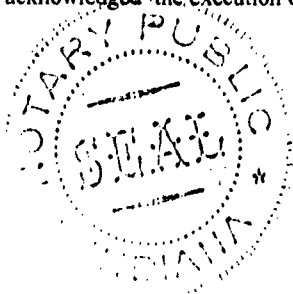
