intents and purposes as I might or could do if personally present.

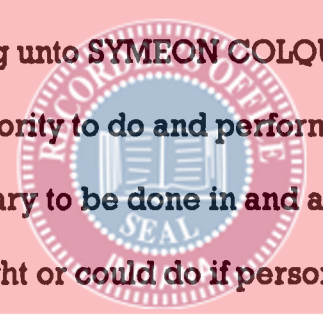
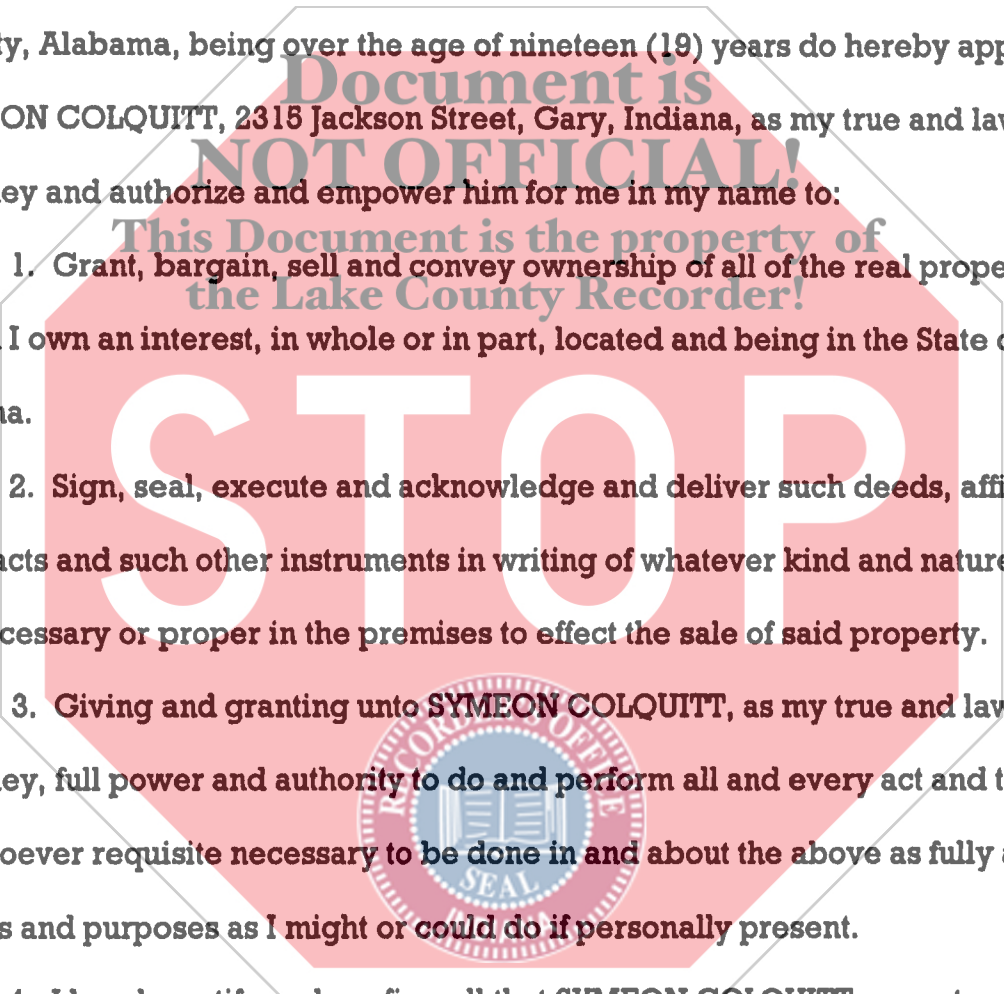
4. I hereby ratify and confirm all that SYMEON COLQUITT as my true and
