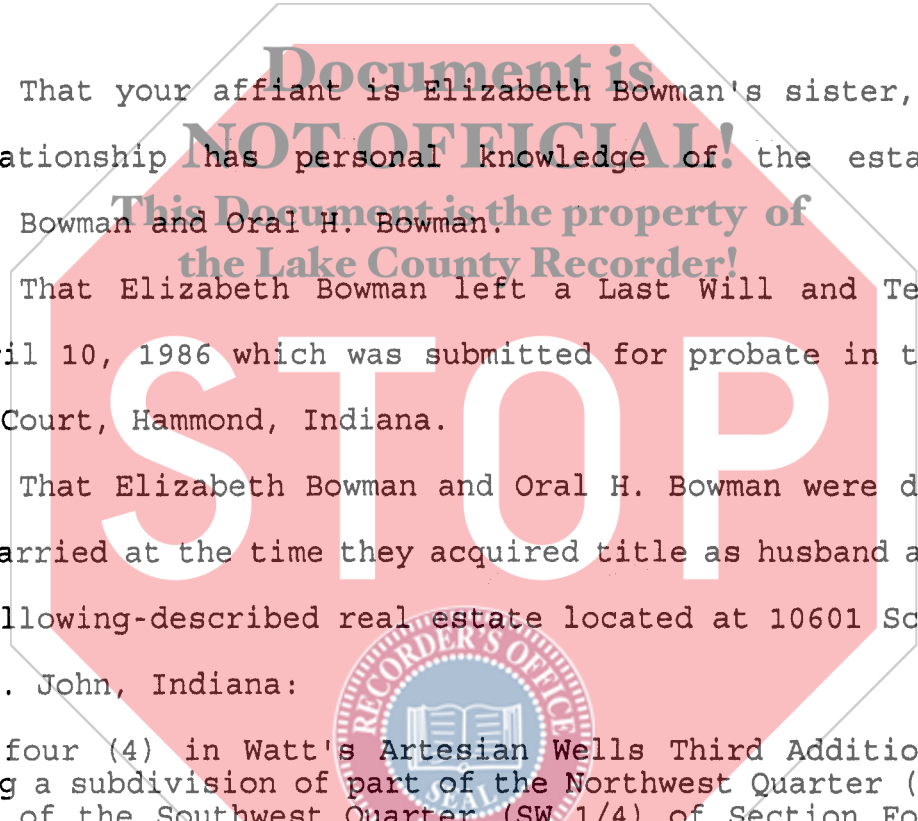

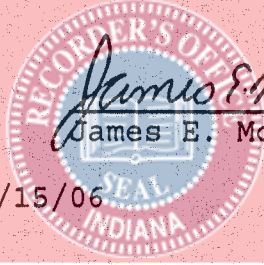
7. That your affiant makes this Affidavit for purpose of clearing title to the above-described real estate in the name of the surviving tenant by the entirety, Oral H. Bowman.
