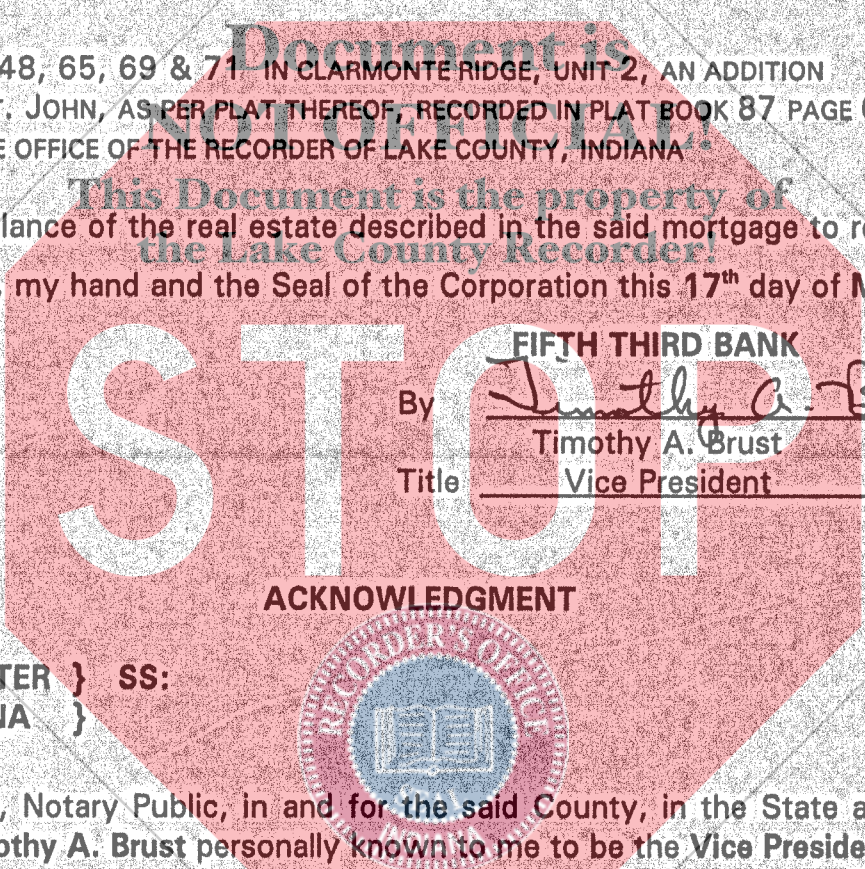
**PARTIAL SATISFACTION OF MORTGAGE**
