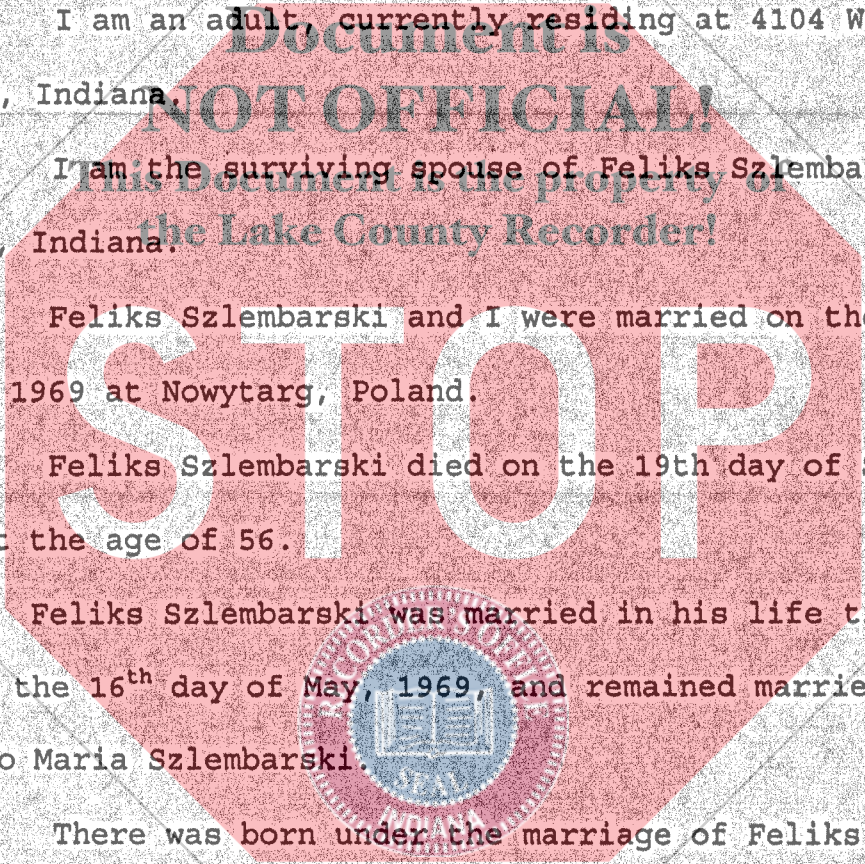
AFFIDAVIT OF HEIRSHIP
