This obligation may be canceled by said Surety by giving thirty (30) days notice in writing of its intention to do so to said Oblige; and provided further, that nothing herein shall affect any rights of liabilities which shall have accrued under this bond prior to the date of termination; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Oblige.

The term of this bond is for a period commencing April 12, 2000 and terminating (or continuous) April 12, 2000 provided, however, this bond may be continued from year to year by continuation certificate executed by said Surety.

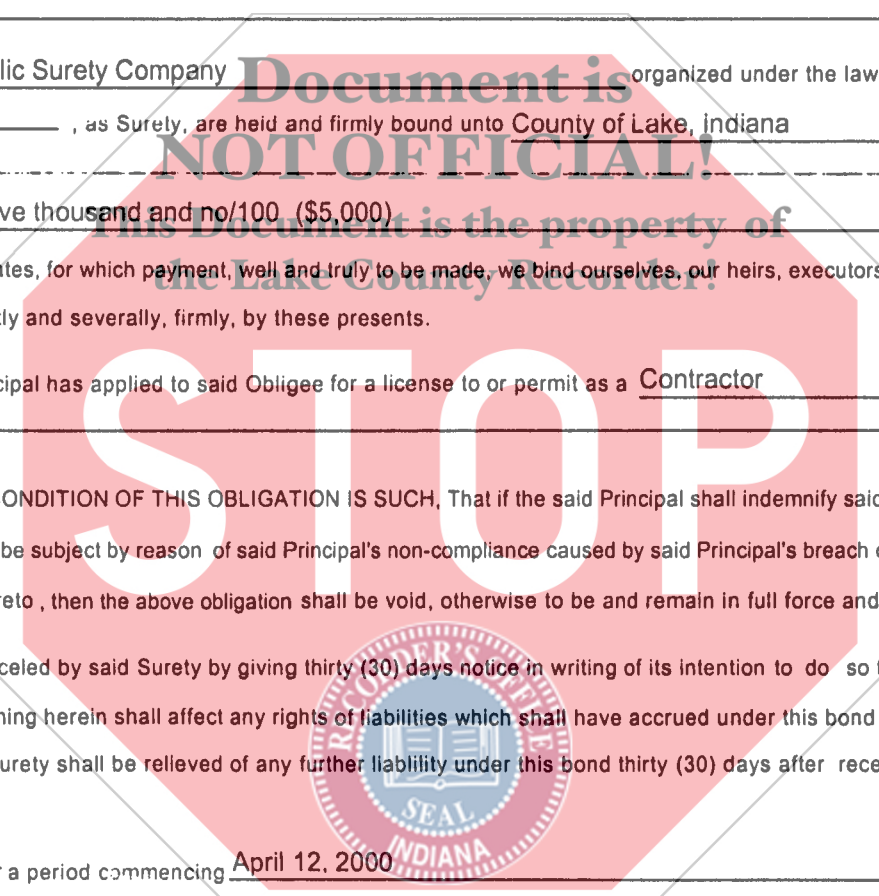

POWER OF ATTORNEY

This Power of Attorney is signed and sealed by facsimile under and by the authority of the following resolutions adopted by the board of directors of the OLD REPUBLIC SURETY COMPANY on February 18, 1982:
