TARTICLE IV FTCTAT

SECTION 7. Resolved, that the signatures of such Officers and the seal of the Company may be affixed to any such power of attorney or to any certificate hearing such facetmile, and any such power of attorney or certificate hearing such facetmile signatures or facetmile seal shall be valid and binding upon the Company and any such power so executed and certified by facetmile signatures and facetmile seal shall be valid and binding upon the Company in the future with respect to any bond or undertaking to which it is statched.
