1. Edward L. Jacobsen, Social Security Number 318-30-5533, died testate on the 23rd day of June, 1995, while domiciled in Lake County, Indiana.
2. No petition for the appointment of a personal representative of the decedent's estate is pending or has been granted.
3. More than forty-five (45) days have elapsed since the death of this decedent.
4. The value of the gross probate estate of this decedent, less liens and encumbrances, does not exceed \$15,000.00.
5. All debts, funeral expenses, and doctor bills of Edward L. Jacobsen have been fully paid.
6. Any and all Federal Estate taxes and/or Indiana Inheritance taxes incurred by virtue of said death have been fully paid.
