Subject to the following restrictions:

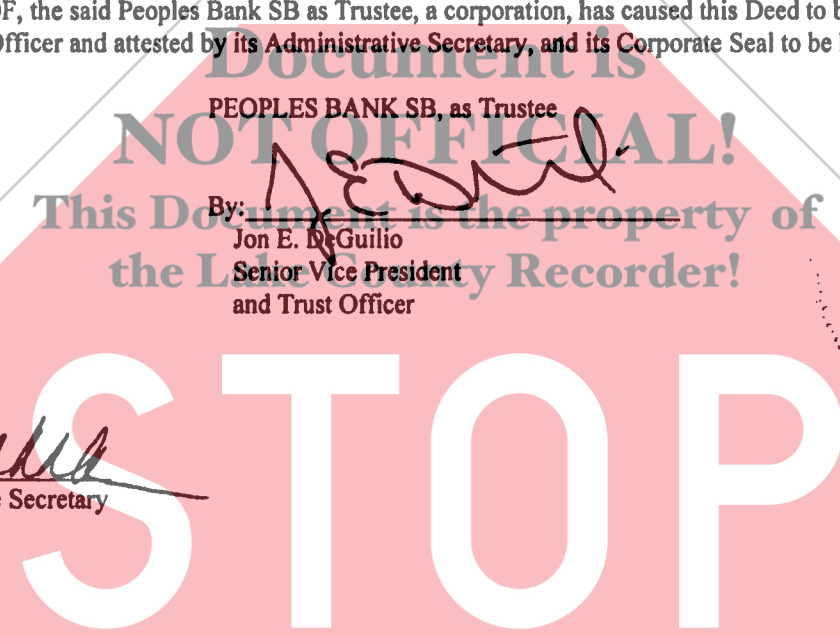
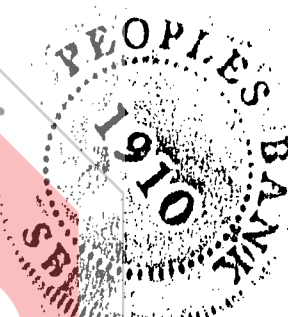
1. All taxes and special assessments for the year 2000 due and payable in 2001 and thereafter;
