



EXHIBIT A

(Legal Description)

A PART OF THE WEST HALF OF SECTION 1, TOWNSHIP 37 NORTH, RANGE 10 WEST OF THE SECOND PRINCIPAL MERIDIAN, IN THE CITY OF HAMMOND; LAKE COUNTY, INDIANA, DESCRIBED AS BEGINNING AT A POINT ON THE WEST LINE OF 5TH AVENUE, THE WIDTH OF WHICH IS 66 PEET WIDE, 33 FEET ON EACH SIDE OF CENTER LINE, SAID POINT IS 600 FEET SOUTH OF THE SOUTH LINE OF 112TH STREET AS IT EXISTS THIS DATE; THENCE WESTERLY ALONG THE SOUTH LINE OF A PARCEL HERETOFORE CONVEYED TO REPUBLIC STEEL CORPORATION, 396.25 FEET, MORE OR LESS, TO THE EAST LINE OF A 30 FOOT EASEMENT CONTAINING SEWER, WATER AND A RAILROAD TRACT; THENCE SOUTHERLY ON SAID EAST LINE OF THE 30 FOOT EASEMENT, WHICH IS A LINE PARALDEL TO AND 1,325 FEET EAST OF THE INDIANA-ILLINOIS STATE LINE, 24 FEET; THENCE WEST AT RIGHT ANGLES, 2.30 FEET TO A LINE THAT IS PARALLEL TO AND 1,322.70 FEET EAST OF THE INDIANA-ILLINOIS STATE LINE, THENCE SOUTHERLY ON SAID 1,322.70 FOOT PARALLEL LINE, 976.00 FEET, THENCE WEST AT RIGHT ANGLES, 5.00 FEET TO A LINE THAT IS PARALLEL TO AND 1,317.70 FEET EAST OF THE INDIANA-ILLINOIS STATE LINE; THENCE SOUTHERLY ON SAID 1,317.70 FOOT LINE, 253.93 FEET, MORE OR LESS, TO THE NORTHWESTERLY LINE OF RIGHT-OF-WAY OF THE 25 FOOT ROAD PARALLELING THE 60 FOOT WIDE RAILROAD STRIP; THENCE NORTHEASTERLY ON SAID NORTHWESTERLY 25 FOOT ROAD RIGHT-OF-WAY, WHICH MAKES AN INTERIOR ANGLE OF 20 DEGREES, 55 MINUTES, 19 SECONDS, MEASURED NORTH TO NORTHEAST WITH AFORESAID 1,317.70 FOOT PARALLEL LINE, 811.90 FEET TO A CURVED LINE; THENCE CONTINUING NORTHEASTERLY ON A CURVE OF 2,012.6 FEET RADIUS CONVEX TO THE NORTHWEST, WHOSE TANGENT MAKES AN INTERIOR ANGLE OF 179 DEGREES, 57 MINUTES, 39 SECONDS, MEASURED SOUTHWEST THROUGH WEST TO NORTHEAST WITH THE LAST DESCRIBED LINE, 271.75 FEET TO THE WEST LINE OF 66 FOOT WIDE 5TH AVENUE PROJECTED SOUTHERLY; THENCE NORTHERLY ON SAID WEST LINE OF 5TH AVENUE, 249.10 FEET TO THE POINT OF BEGINNING, AND THE WEST HALF OF THAT PORTION OF VACATED 5TH AVENUE ADJACENT TO THE EAST SIDE OF THE LAND.
