

Parcel 1: Lots 9 and 10 in Block 7 in Noble Oaks Park 2<sup>nd</sup> Addition, Cedar Lake, as per plat thereof, recorded in Plat Book 27, page 20 in the Office of the Recorder of Lake County, Indiana.

Parcel 2: Part of the Northeast 1/2 of Section 34, Township 34 North, Range 9 West of the Second Principal Meridian and part of Outlot "A" in Noble Oaks Park 2nd Addition, Cedar Lake, described in one tract as follows: Beginning at a point where the North line of Lot 9, Block 7, Noble Oaks Park 2nd Addition, intersects the West line of the abandoned Chicago, Indianapolis and Louisville Railway Company's right of way, thence East, along the North line of Lot 9 extended to the shore of Cedar Lake; thence Southerly along the shore of Cedar Lake to the point of intersection of said shore with the South line of Lot 10, Block 7, extended East; thence West, along the South line of said Lot 10 extended to the Southeasterly corner of said Lot; thence Northerly along the East lines of Lots 9 and 10, 50 feet to the place of beginning, in Lake County, Indiana
