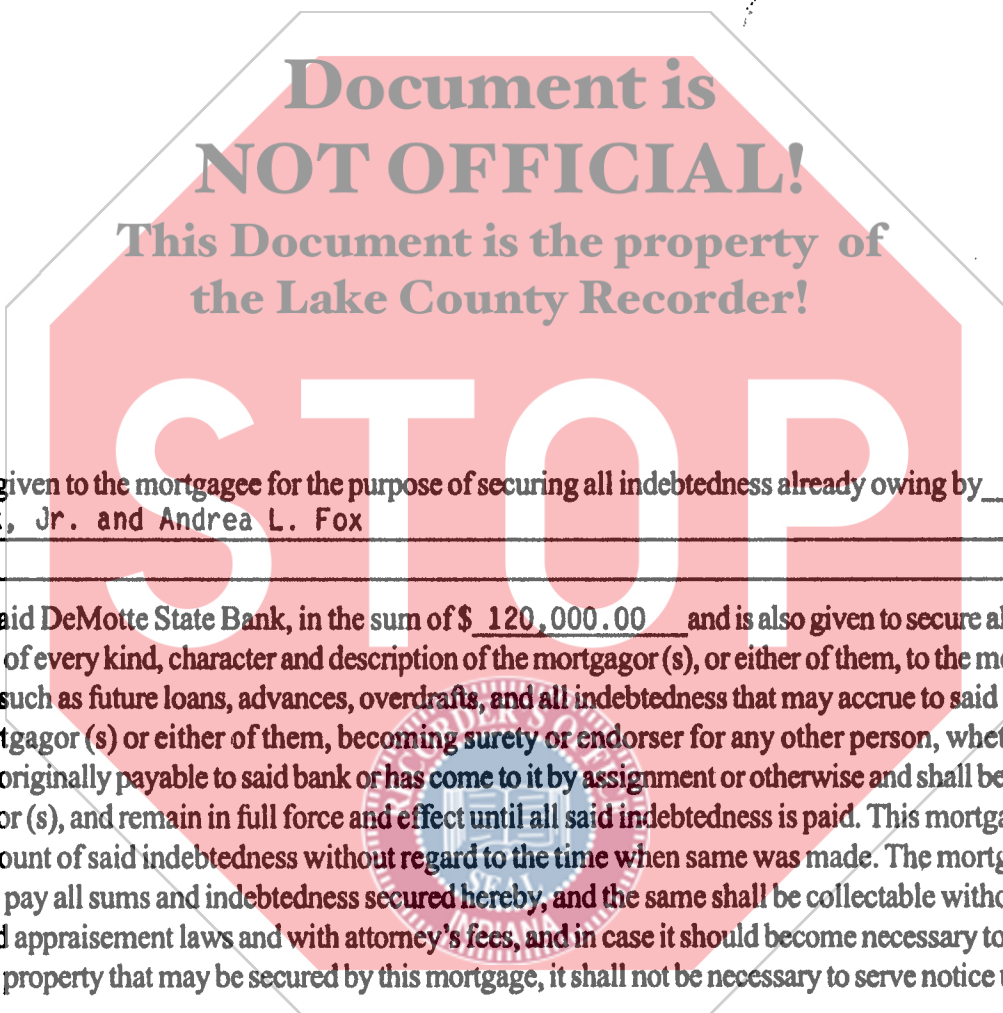
INDEMNIFYING MORTGAGE

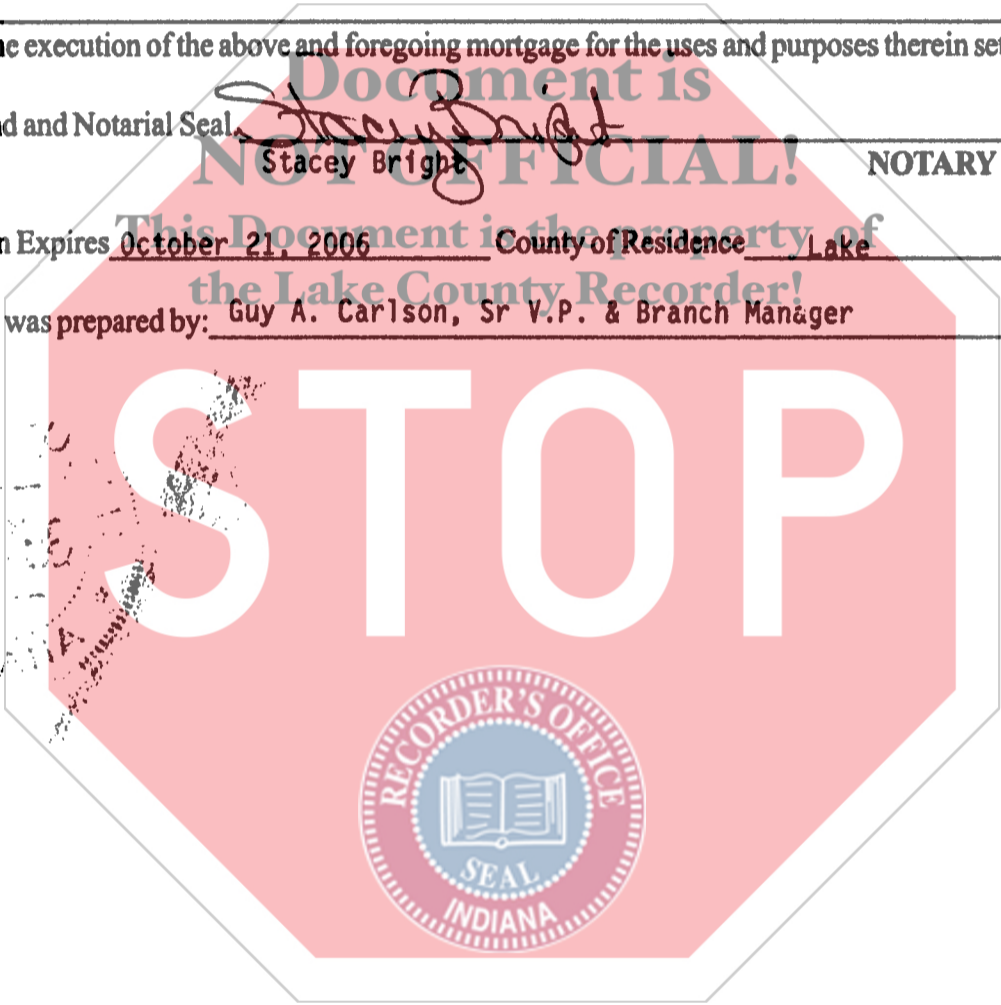
