KNOW ALL MEN BY THESE PRESENTS, That we,

KIEPURA-STEWART ROOFING, INC., 1901 EAST END AVENUE, CHICAGO HEIGHTS, IL 60411, as Principal,

and **OLD REPUBLIC SURETY COMPANY**, organized under the laws of the state of Wisconsin, as Surety, are held and firmly bound unto

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, That if the said Principal shall indemnify said Obligee against all loss which the Obligee may be subject by reason of said Principal's non-compliance caused by said Principal's breach of any ordinance, rule or regulation relating thereto, then the above obligation shall be void, otherwise to be and remain in full force and effect.


This obligation may be cancelled by said Surety by giving thirty (30) days notice in writing of its intention to do so to said Obligee; and provided further, that nothing herein shall affect any rights of liabilities which shall have accrued under this bond prior to the date of termination; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Obligee.

The term of this bond is for a period commencing **8/20/2000** and terminating (or continuous) **8/20/2001** provided, however, this bond may be continued from year to year by continuation certificate executed by said Surety.

"Shall save and keep harmless the City of Berwyn from all liability to any person or reason of damage to any person or property as a result of the operations performed under such license.

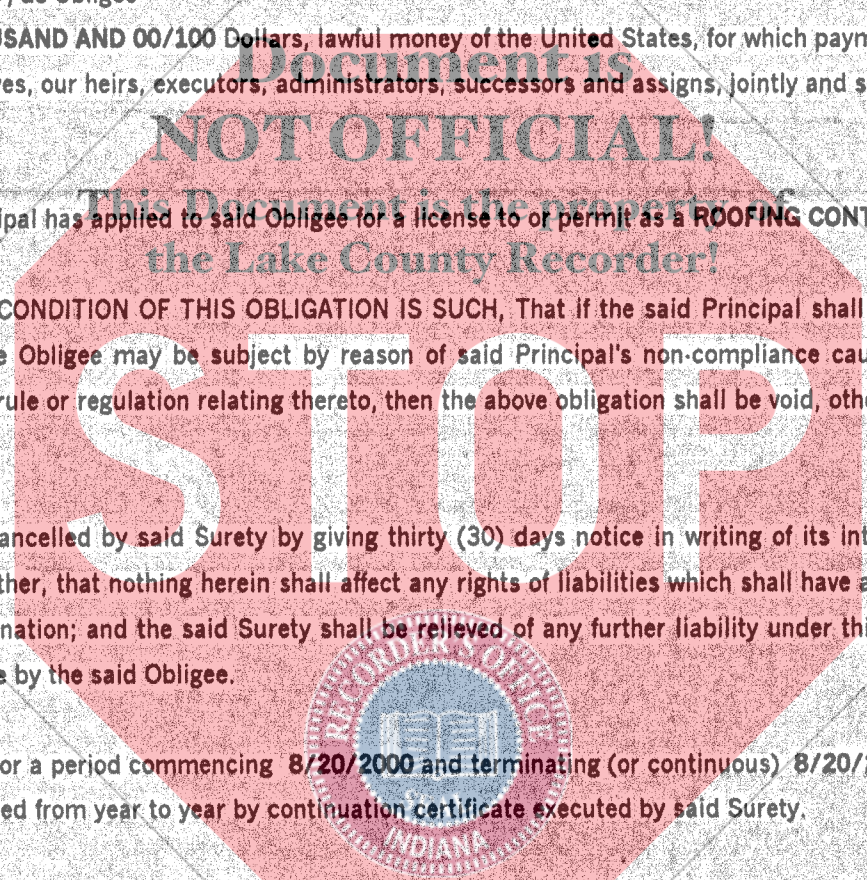

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That OLD REPUBLIC SURETY COMPANY, a Wisconsin stock insurance corporation, does make, constitute and appoint:

Its true and lawful Attorney(s)-in-Fact, with full power and authority for and on behalf of the company as surety, to execute and deliver and affix the seal of the company thereto (if a seal is required), bonds, undertakings, recognizances or other written obligations in the nature thereof (other than bail bonds, bank depository bonds, mortgage deficiency bonds, mortgage guaranty bonds, guarantees of installment paper and note guaranty bonds, self-insurance workers compensation bonds guaranteeing payment of benefits, asbestos abatement contract bonds, waste management bonds, hazardous waste remediation bonds or black lung bonds), as follows:
