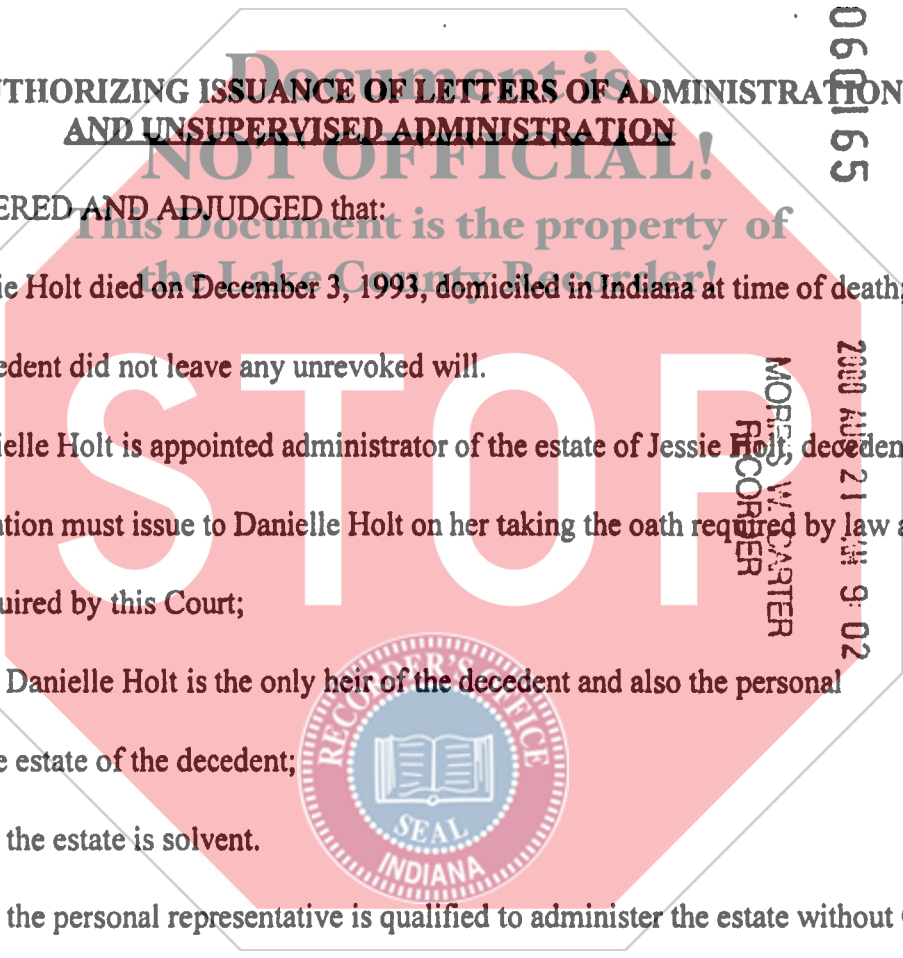
**ORDER AUTHORIZING ISSUANCE OF LETTERS OF ADMINISTRATION

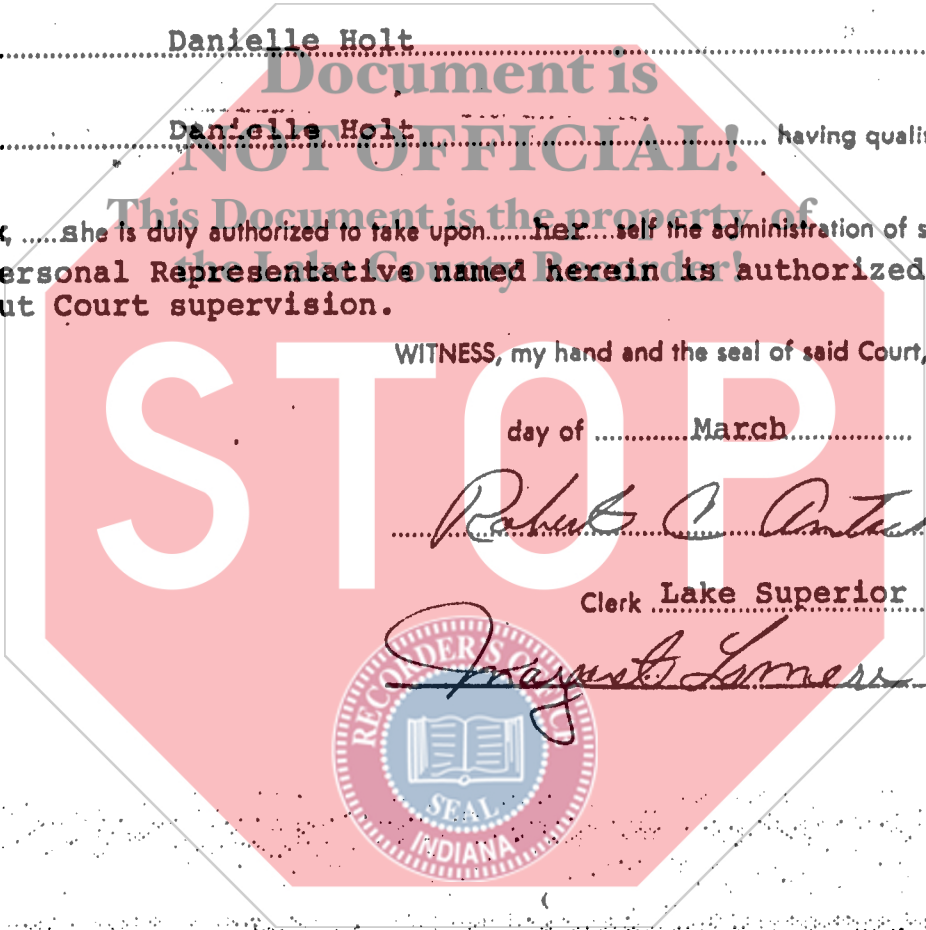
