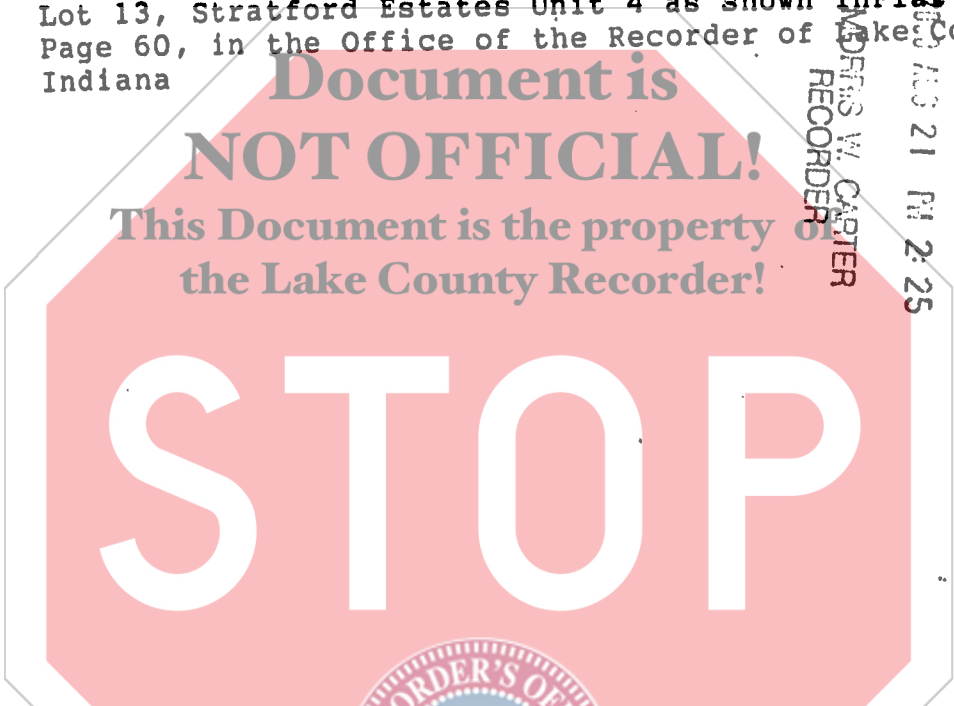
This Indenture Witnesseth, That Dale G. Vehey and Sue A. Vehey,
