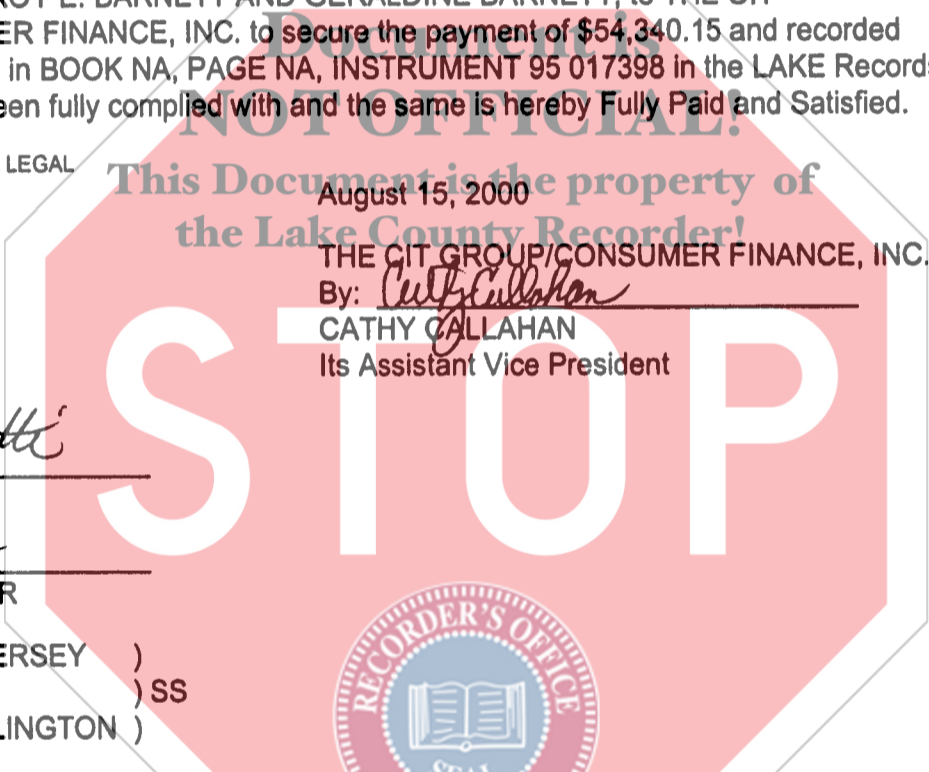

LEGAL DESCRIPTION - EXHIBIT "A"

ROY E. BARNETT & GERALDINE BARNETT

COMMENCING AT A POINT AT THE INTERSECTION OF THE NORTH LINE OF CHICAGO AVENUE AND THE WEST LINE OF HARRISON STREET, IN THE CITY OF GOSHEN, INDIANA; THENCE NORTH 54 DEGREES WEST THREE HUNDRED SIXTY-SIX (366) FEET; THENCE NORTH THIRTY-THREE AND ONE-HALF (33 1/2) DEGREES EAST, ONE HUNDRED SIXTY-FOUR AND NINE TENTHS (164.9) FEET TO THE SOUTH BANK OF THE ELKHART RIVER; THENCE IN A SOUTHEASTERLY DIRECTION WITH THE TREND OF SAID RIVER TO A POINT ON SAID SOUTH RIVER BANK DUE NORTH OF THE PLACE OF BEGINNING, TWO HUNDRED FORTY-TWO (242) FEET; THENCE SOUTH TWO HUNDRED EIGHTY-FIVE (285) FEET TO THE PLACE OF BEGINNING. EXCLUDING SIXTY (60) FEET ON THE WEST SIDE OF THE PROPERTY. BEING A PART OF THE NORTHEAST QUARTER (NE 1/4) OF SECTION 8, TOWNSHIP 36 NORTH, RANGE 6 EAST.
