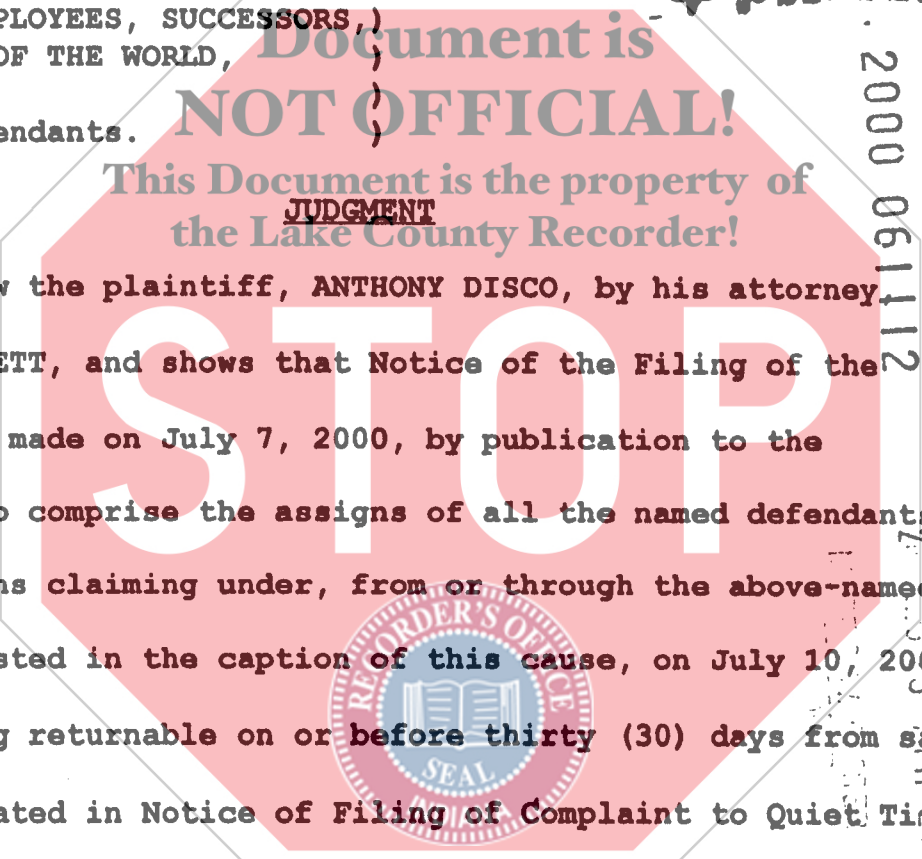

Thereupon this cause is submitted to the Court for hearing and trial without the intervention of a jury and the Court having heard all of the evidence and being duly advised, in the premises, now finds that ANTHONY DISCO, is the fee simple owner of the following real estate in Lake County, Indiana, to wit:

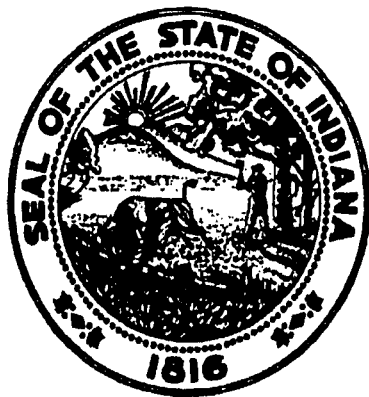
