# TAX TITLE DEED TO COUNTY

Whereas the LAKE County Board of Commissioners did the 3rd day of April, 2000 produced to the County of LAKE, in the State of Indiana, a certificate of sale dated the 20th day of September, 1999, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that said County on the 20th day of September, 1999, obtained, pursuant to law, the real property described in this indenture for the sum of ONE THOUSAND, TWO HUNDRED SIXTY-EIGHT AND 1/100 DOLLARS (\$1,268.01) being the amount due on the following tracts of land returned delinquent in the name KIRTLAND FERN C TR for 1998 and prior years, namely:

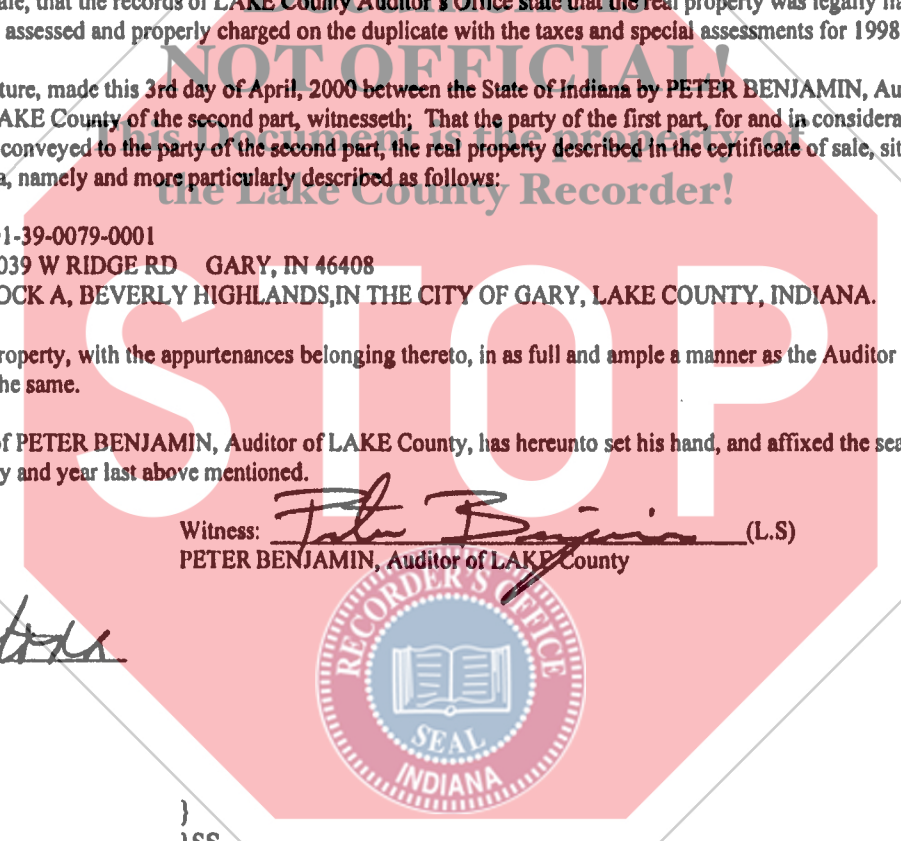
