**PROPERTY DESCRIPTION**

Tract 46 of Plat of Survey of that Part of the S.W. 1/4 NE 1/4 Sec. 19, T.34 N R 8 W of the 2nd PM. lying West of the Center line of the Crown Point Lowell Road more particularly described as follows: commencing at the intersection of the North line of the S.W. 1/4 NE 1/4 Sec. 19 with the West line of the Crown Point Lowell Road, said West line being 30 ft. Westerly of the center line of said road measured at right angles thereof thence Southwesterly along the Westerly line of said road a distance of 813.12 ft., thence Northwesterly at right angles to said a distance of 202.81 ft., being the point of beginning, thence Northeasterly with an angle of 92 degrees 44 minutes with the aforesaid line a distance of 36.27 ft., thence West with an interior angle of 66 degree, 36 minutes and 30 seconds a distance of 195.28 ft., thence South with an interior angle of 90 degrees a distance of 70 ft., thence East with an interior angle of 90 degrees a distance of 165 ft. to point of beginning.
