Part of Lot 16, Cobblestones Townhomes, Phase Two, an addition to the Town of Munster, as recorded in Plat Book 77, page 69, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Commencing at the Northwest corner of said Lot 16; Thence South 00 degrees 50 minutes 32 seconds West, along the West line of said Lot 16, a distance of 8.72 feet to a point of curve; Thence Southeasterly along said curve being concave to the Northeast, and having a radius of 170.00 feet, an arc distance of 94.98 feet to the point of beginning; Thence North 49 degrees 34 minutes 13 seconds East, a distance of 132.04 feet to the Northeasterly line of said Lot 16; Thence South 44 degrees 28 minutes 18 seconds East, along said Northeasterly line, a distance of 28.70 feet; Thence South 49 degrees 34 minutes 13 seconds West, a distance of 136.27 feet to a point on a curve, said curve being the Southwesterly line of said Lot 16; Thence Northwesterly, along said curve being concave to the Northeast and having a radius of 170.00 feet, an arc distance of 28.75 feet, to the point of beginning, all in the Town of Munster, Lake County, Indiana.
