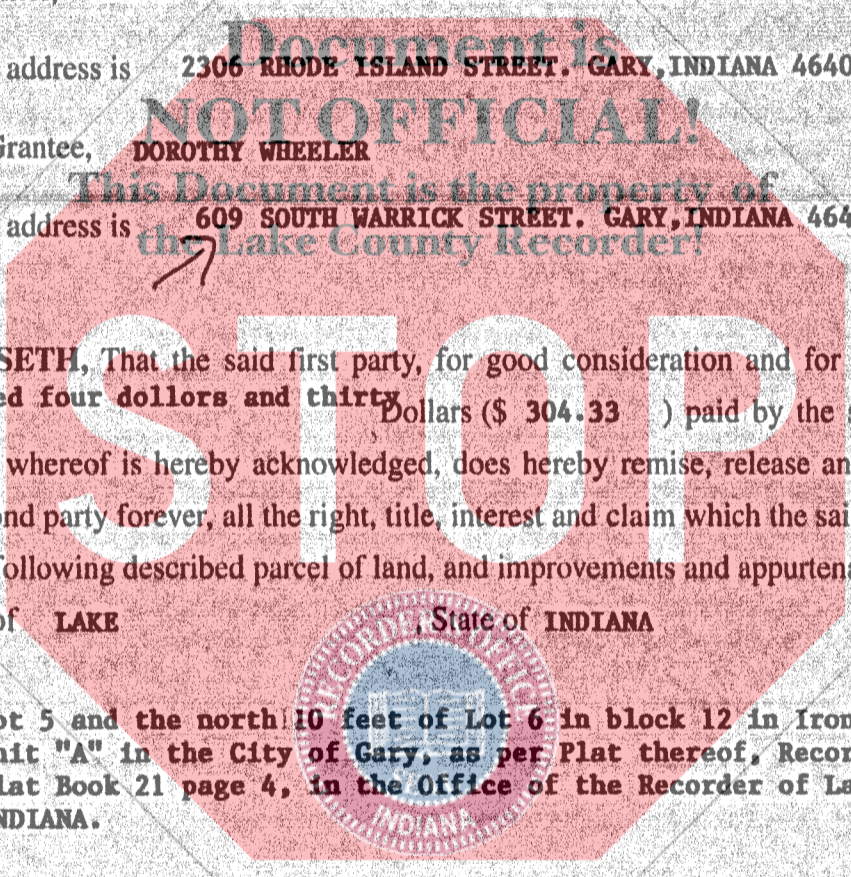
THIS QUITCLAIM DEED, Executed this 24 day of AUGUST, (year), 2000
