5. Hazard or Property Insurance. Borrower's covenants and agreements shall be joint and several. Any Borrower who co-signs this Security Instrument but does not execute the Note: (a) is co-signing this Security Instrument only to mortgage, grant and convey that Borrower's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without that Borrower's consent.

Loan Charges. If the loan secured by this Security Instrument is subject to a law which sots maximum loan charges, and that law is finally interpreted so that the interest or other losh charges collected or to be collected in connection with the long exceed the permitted limits, then: (a) any such loag charge shall be reduced by the amougt necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. 15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. In the event that any provision or clause of this Security Instrument or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are declared to be severable.

16. Borrywer's Copy. Borrower shall be given one conformed copy of the Note and of this Security Lastrument.

17. Transfer of the Property or a Beneficial interest in Borrower. The notice shall specify: (a) the default; (b) the action required to cure the default; (c) u date, not less than 30 days from the date the notice is given to Borrower, by which the default must be
