RELEASE AND TERMINATION AS W. CARTER OF RIGHTS OF FIRST REFUSAL

THIS INDENTURE is entered into between ROBERT J. LAMBERT and CATHERINE E. LAMBERT, Husband and Wife (hereinafter referred to collectively as "Lamberts"), and JOHN S. SIMA and JILL G. SIMA, Husband and Wife (hereinafter referred to collectively as "Simas").

WHEREAS, Simas signed and delivered to Lamberts a Right of First Refusal dated January 13, 1994 (hereinafter "Lamberts' Right of First Refusal") that was filed in the Office of the Recorder of Lake County, Indiana as Document No. 94005354 on January 20, 1994 and which document gave the Lamberts a right of first refusal to purchase certain real estate owned by Simas and legally described as follows:

Lamberts and Simas mutually release and discharge the other from any rights, obligations, claims, expenses, costs, and damages which either may have the right to assert or demand against the other, and which may arise or accrue as a result of the Simas' Right of First Refusal and the Lamberts' Right of First Refusal.
- 2. The Simas' Right of First Refusal and the Lamberts' Right of First Refusal are TERMINATED and of no effect. Simas hereby disclaim, waive, and release all rights or interests they may have in or to the Lambert Real Estate, including, but not limited to, any rights to purchase said real estate arising under the Simas' Right of First Refusal. Lamberts hereby disclaim, waive, and release all rights or interests they may have in or to the Sima Real Estate, including, but not limited to, any rights to purchase said real estate arising under the Lamberts' Right of First Refusal
