### TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 4<sup>TH</sup> day of October, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 15<sup>th</sup> day of March, 1999 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 15<sup>th</sup> day of March, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of \$676,788.99 (Six Hundred Seventy Six Thousand Seven Hundred Eighty Eight Dollars and ninety nine cents), being the amount due on the following tracts of land returned delinquent in the name HERBERT G. WHYTE for 1998 and prior years, namely:
