# TAX TITLE DEED TO COUNTY

Whereas the LAKE County Board of Commissioners did the 7th day of August, 2000 produced to the County of LAKE, in the State of Indiana, a certificate of sale dated the 20th day of March, 2000, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that said County on the 20th day of March, 2000, obtained, pursuant to law, the real property described in this indenture for the sum of (\$4,350.17) FOUR THOUSAND, THREE HUNDRED FIFTY AND 17/100 DOLLARS being the amount due on the following tracts of land returned delinquent in the name MBANU GLORIA for 1998 and prior years, namely:
