of Lake County, in the State of Indiana, Convey and Warrant to Wesley E. Miller and Anita B. Miller, husband and wife, ("Grantees")

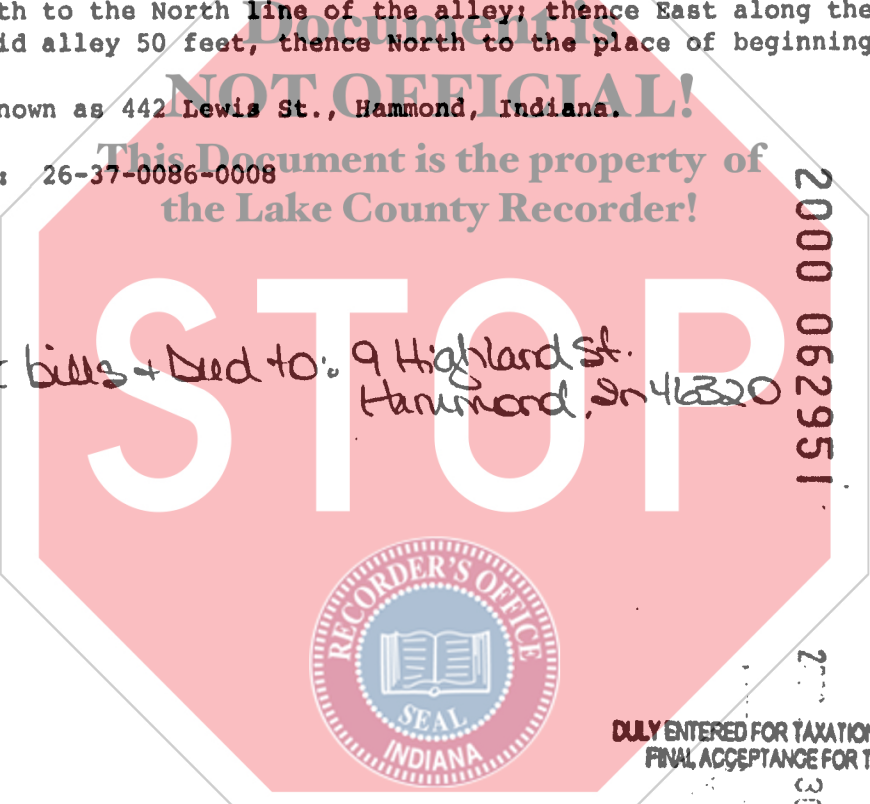

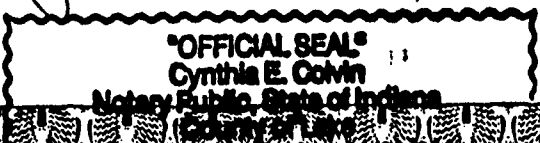
