# TAX DEED

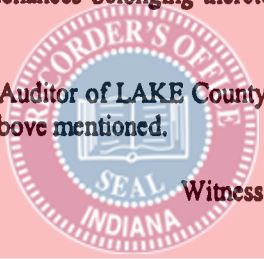
