Commonly known as: 7731 Murrelet Street, Hobart, Indiana 46342

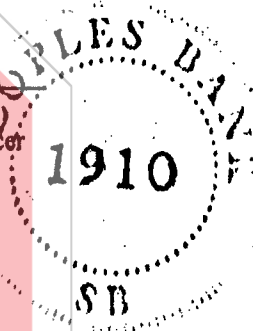
Subject to the following restrictions:

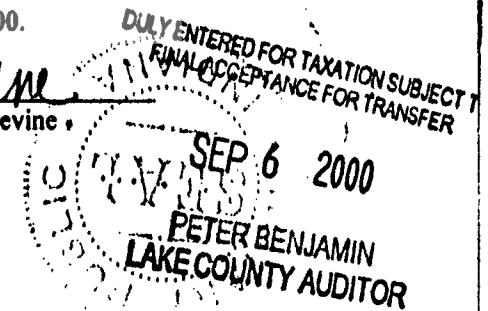
