KNOW ALL MEN BY THESE PRESENTS: that Carteret Federal Savings bank, in receivership, Federal Deposit Insurance Corporation as Receiver, (Successor to Carteret Savings Bannk, F.A. and Carteret Savings and Loan Association) the owner and holder of a certain mortgage executed by GEORGE M. WHEREAS, effective April 23, 1982, Carteret Savings and Loan Association converted to a federal savings and Loan association, effective May 5, 1982, changed its corporate title to Carteret Savings and Loan Association, F.A., and effective January 15, 1986 changed it corporate title to Carteret Savings Bank, F.A.;

WHEREAS, on December 4, 1992, by Order No. 92-509, the Office of Thrift Supervision, Department of the Treasury of the United States ("OTS") closed Carteret Savings Bank, F.A. ("Carteret") and declared it insolvent and appointed The Resolution Trust Corporation ("RTC") as sole receiver ("the Receiver") for the purpose of liquidation.

WHEREAS, on December 4, 1992, by Order No. 92-509, the OTS created and chartered a new federal mutual savings association known as Carteret Federal Savings Bank ("Carteret Federal") and the RTC was appointed as conservator (the "Conservator") for Carteret Federal.

WHEREAS, on December 4, 1992, by Order No. 92-509, the RTC in its capacity as the Receiver of Carteret entered into a Purchase and Assumption Agreement with RTC in its capacity as Conservator for Carteret Federal whereby substantially all of the assets, including all right, title and interest to the mortgage described herein, was transferred, assigned, conveyed and delivered to Carteret Federal.

WHEREAS, the OTS, by Order No. 95-49, dated March 10, 1995, replaced the Conservator of Carteret Federal Savings Bank with the RTC as Receiver of Carteret Federal Savings Bank for the purpose of liquidation.

WHEREAS, the Federal Deposit insurance Corporation ("FDIC"), acting in its capacity as receiver for Carteret Federal Savings Bank, which pursuant to 12 U.S.C. Section 1441a(M)(1) succeeded The Resolution Trust Corporation ("RTC") in its capacity as receiver for Carteret Federal Savings Bank.

WHEREAS, by operation of law, the Receiver has succeeded to all of the rights, title, powers and privileges of Carteret Federal, and, therefore, the Receiver is the present owner and holder of the Mortgage described herein.

THE RECEIVER hereby acknowledges full payment and satisfaction of said note and mortgage and surrenders the same as canceled and hereby direct the Clerk of LAKE County to cancel the same of record.
