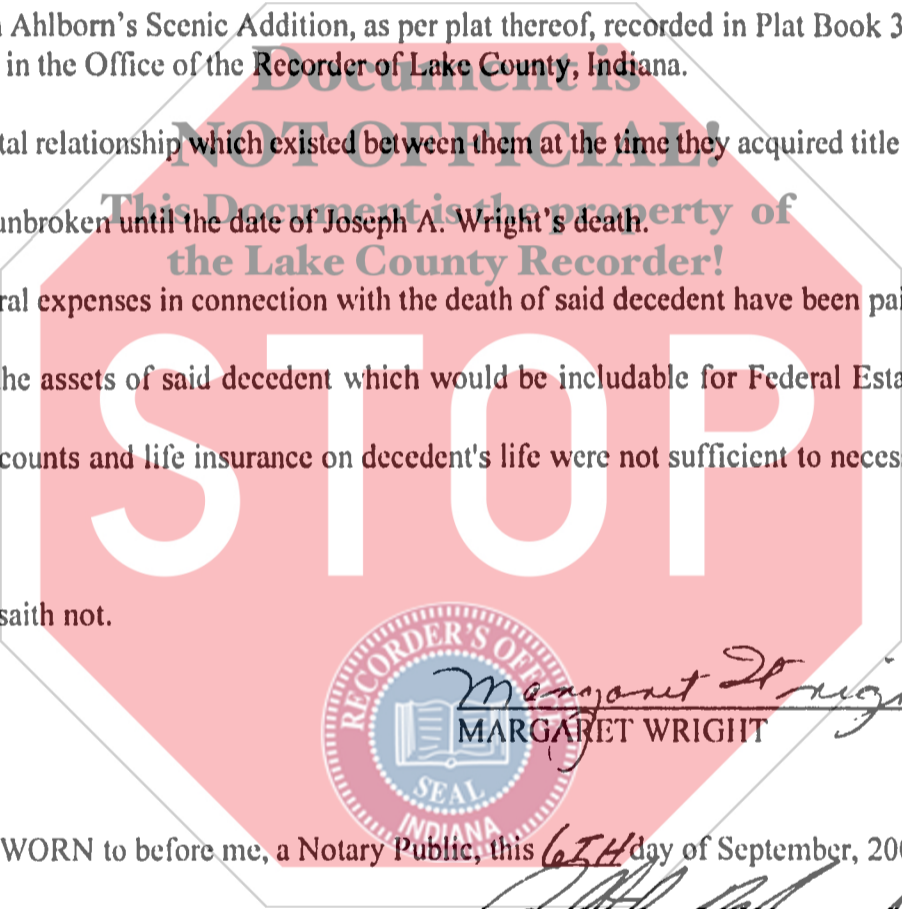
MARGARET WRIGHT, being first duly sworn upon her oath, deposes and says:
